

High Life Flight (HLF) mishap

- Air ambulance is market driven
- Mishap occurred in December 2022
- Resulted in grounding of HLF fixed wing aircraft
- Air ambulance capacity was reduced for about 6 weeks
- Relied on National Guard and Coast Guard to assist
- HLF has returned to full operations
- Incident demonstrated vulnerability of statewide air ambulance



COVID-19 Pandemic

- Public health emergency ended in March 2023
- COVID-19 vaccine and treatment has been commercialized
- DOH continues its surveillance, wastewater testing, and reporting




Hawaii COVID-19 Cases and Testing | **SUMMARY**





- DOH issued an amended emergency order on May 6, 2022, to the U.S. Navy to defuel and permanently close the Red Hill Bulk Fuel Storage Facility (RHBFSF).
- To prepare for safe and expeditious defueling, the DOH Solid and Hazardous Waste Branch:
 - 1. Reviewed hundreds of quality validation reports for repairs;
 - 2. Participated in weekly coordination meetings with the EPA and U.S. Navy; and
 - 3. Coordinated and participated in numerous spill response exercises.
- DOH pushed DoD for more expeditious defueling while ensuring safety.



104 million gallons removed

- In December 2023, five months earlier than originally scheduled, DOH oversaw JTF-RH's gravity defueling.
- DOH Safe Drinking Water Branch continues to monitor the test results collected under the Drinking Water Long-Term Monitoring plan.
- DOH continues to oversee the Navy's closure of RHBFSF and aquifer remediation.





- Activated our Department Operations Center
- DOH had lead for ESF-8 and ESF-10
- Created Maui Wildfire Response website: health.hawaii.gov/mauiwildfires/





Maui Wildfires: Medical Care

- Coordinated and provided medical care in congregate and non-congregate shelters as well as in the community
- Organized and staffed healthcare services available through the Lahaina Comprehensive Health Center and community outreach
- Supported Lahaina burn area reentry by:
 - Providing education and distribution of personal protective equipment;
 - Hosting reentry stations for basic medical and behavioral healthcare; and
 - Staffing vehicles to monitor lagging zones






Maui Wildfires: Behavioral Healthcare

- Expanded access to its Community Mental Health Center in Wailuku and established a new Certified Community Behavioral Health Center in Lahaina
- Partnered to provide wellness checks and mental health counseling in shelters
- Awarded \$680K from FEMA to support a Crisis Counseling Program, and an additional \$4.4M from SAMHSA to continue and expand these services
- Received \$17M from SAMHSA for a Supplemental Emergency Response Grant (SERG) over a two-year period to establish a resiliency center
 - Direction of the resiliency center will be determined by the community and include intervention activities, training resources, case management, and peer support
- Received \$450K in supplemental funds from SAMHSA to expand services for affected children and adolescents


Weekly count of total emergency department visits associated with mental health

Weekly count of emergency department visits by suicidal ideation and suicide attempt





Maui Wildfires: Environmental Health

- Conducted air and ash testing
- Established a network of real-time air monitors: fire.airnow.gov
- Provided technical support to the Maui Department of Water Supply
- Assisted U.S. EPA on Phase I removal of Household Hazardous Materials, worked with the US Coast Guard on marine debris removal, and coordinated with USACE on cleanup standards of private properties
- Overseeing Maui County's final debris disposition plan to include its compliance with siting analysis, design and operations criteria, groundwater protection, and closure and post-closure care
- Assisting wastewater infrastructure plans for construction project of 200 temporary homes





State Operated Specialized Residential Program (SOSRP) incident

- A DOH employee was fatally injured by a resident in the SOSRP on November 13
- We conducted a safety stand-down of SOSRP and the Hawaii State Hospital to perform a comprehensive safety review
- Some measures were immediately implemented, others will require additional resources:
 - Facility repairs and enhancements
 - Personnel and contracted services
 - Provider rate increases
 - Community residential capacity
- Timing didn't allow inclusion in Governor's budget and we are pursuing other means of introducing this request



Selected regular operations accomplishments

- Fulfilled 73,625 vital record requests January 1, 2023 to December 1, 2023, reducing average processing time from six to three weeks
- Led several public education campaigns to help people stay healthy:
 - Sweet Lies! to reduce overconsumption of sugar sweetened drinks by children
 - Control Asthma to educate on asthma prevention, signs, and managing symptoms
 - BE FAST to increase awareness of stroke symptoms and need for quick action
- Successfully transferred EMS from State to City & County of Honolulu, and awarded 8 stipends to attend KCC paramedic program
- Awarded \$5 million in grants for cesspool conversions
- Formally launched a Climate and Health program
- Created new Behavioral Health Dashboard: bh808.hawaii.gov



Operational challenges

- Morale!
- Payment delays and miscalculations, errors in document processing
- Delay in contracting and decreased robustness of contractual oversight
- Delay in licensing and responding to complaints of illegal care home
- Decreased robustness of contact tracing
- Delay in processing clean air permits
- Delay in remediating contaminated sites
- Decreased ability to timely transition HSH patients
- Decreased ability to promote prevention

- DOH has adapted statewide telework guidance
- Maximum 3 days per week, unless as a reasonable accommodation
- Approval initially for 6 month period, now a 12 month period
- New/renewal requires a current performance evaluation
- 236 employees (<10% of staff) have a telework agreement
 - 21% 1 day/wk
 - 39% 2 days/wk
 - 36% 3 days/wk
 - 3% >3days/wk and on a RA



Supplemental Budget Request 1/2

- \$58,447,572 A-funds
- 13 new FTEs (9 A-funds)
- Mental Health
 - \$6.7 M for the Iwilei Resource Center (behavioral health crisis center)
 - \$20.0 M for Hawaii State Hospital employed staff overtime and inpatient contracts
 - \$13.0 M for Hawaii State Hospital contracted locum tenens staff
 - \$10.8 M for child and adolescent behavioral health care provider rate increases
 - 4 positions for a Certified Community Behavioral Health Center on Maui
- Not included
 - \$14.3 million for HSH safety response








Patient to Staff Aggression Events per 1,000 Patient Days (Minus Peds.)








Assault Staff Injuries per 1,000 Patient Days









Annualized Staff Turnover Rate








Average Daily Cost per Staffed Bed








Average Length of Stay
