Wednesday, April 29, 2015

The House of Representatives of the Twenty-Eighth Legislature of the State of Hawaii, Regular Session of 2015, convened at 11:41 o'clock a.m, with Speaker Souki presiding.

The invocation was delivered by Ohana Arts, after which the Roll was called showing all Members present with the exception of Representative Belatti, who was excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Fifty-Fifth Day was deferred.
