
A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
THIRTY-EIGHTH REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Mililani high school's stadium is the venue for
2 many of the Oahu interscholastic association sporting events.
3 Because the field is grass, it requires a great deal of
4 maintenance. However, none of the other schools using the field
5 are required to share in the maintenance and the responsibility,
6 which means that the cost of maintenance falls to Mililani high
7 school. Installation of synthetic turf would be easier and less
8 costly to maintain and ensure that the field would be in the
9 best condition possible for interscholastic sporting events.

10 Mililani middle school serves all middle school age
11 children in Mililani. Because there is very heavy rainfall in
12 the Mililani mauka area where the school is located, there is a
13 need to provide covered bus stops for the health and safety of
14 students.

15 The purpose of this Act is to provide funding for capital
16 improvement projects in the thirty-eight representative
17 district.



1 SECTION 2. The following sums, or so much thereof as shall
2 be sufficient to finance the projects listed in this Act, are
3 hereby appropriated out of the general revenues of the State of
4 Hawaii for fiscal year 2008-2009:

5 1. To be expended by the department of education:

6 A. Mililani high school, Oahu

7 Plans, design, and construction for the installation
8 of synthetic turf in the sports stadium.
