TWENTY-FIFTH DAY

Friday, March 6, 2009

The House of Representatives of the Twenty-Fifth Legislature of the State of Hawaii, Regular Session of 2009, convened at 12:04 o'clock p.m., with the Speaker presiding.

The invocation was delivered in song by Mr. Richard "Klunx" Ah Lee Sam, III, of the Chief Clerk's Office, after which the Roll was called showing all members present with the exception of Representatives Berg, Chong, Finnegan and Takai, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Twenty-Fourth Day was deferred.

At this time, the Chair announced:

"Members of the House, prior to going on to the Order of the Day, the Chair would like to request your indulgence since most of these measures are on Second Reading. If you're going to state your comments, for or against, on Second Reading, they should be incorporated in your remarks for Third Reading. I would like to adjourn session today by 1:00 this afternoon so our Neighbor Island Members can catch their flights home. If you're going to speak on Second Reading, we'll incorporate that as part of Third Reading. If you don't speak on Second Reading, then you can speak on Third Reading.

"Let's move on Members of the House, to the Order of the Day, Unfinished Business. Members, please note that House Bill No. 1503, House Draft 1, has been re-referred solely to the Committee on Economic Revitalization, Business, & Military Affairs per Committee Referral Sheet No. 25 that has been placed on your desk today. The Committee on Judiciary waived its referral to this measure, and therefore it is appropriate for the House to consider action for passage on Third Reading."

SUSPENSION OF RULES

Representative B. Oshiro moved to suspend the rules of the House to reconsider action previously taken on H.B. No. 1503, HD 1, seconded by Representative Evans.

At this time, the Chair addressed Representative McKelvey, stating:

"Representative McKelvey, what is the Motion before this House?"

Representative McKelvey responded, stating:

"The Motion before this House, Mr. Speaker, is to reconsider the recommendations made in the Standing Committee Report to move this on to the Judiciary Committee, and to instead bring this motion before the Body for Third Reading."

The Chair then stated:

"You're absolutely correct. Thank you, very much."

The motion was put to vote by the Chair and carried, and the rules were suspended to reconsider action previously taken on H.B. No. 1503, HD 1. (Representatives Berg, Finnegan and Takai were excused.)

**RECONSIDERATION OF
ACTION TAKEN**

Representative B. Oshiro moved that the House reconsider its action previously taken pursuant to the recommendation contained in Standing Committee Report No. 604, recommending referral to the Committee on Judiciary, seconded by Representative Evans and carried. (Representatives Berg, Finnegan and Takai were excused.)

SUSPENSION OF RULES

On motion by Representative B. Oshiro, seconded by Representative Evans and carried, the rules were suspended for the purpose of considering certain House bills for Third Reading by consent calendar. (Representatives Berg, Finnegan and Takai were excused.)

UNFINISHED BUSINESS

H.B. No. 1503, HD 1:

Representative B. Oshiro moved that H.B. No. 1503, HD 1, pass Third Reading, seconded by Representative Evans.

Representative McKelvey rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. This measure basically is looking at setting up a new limited liability company for what they call, public purpose corporations. A public purpose corporation is one where the bottom line isn't maximizing profits to the shareholders. It's about supporting a higher public good. Legislation like this is being considered in other bodies across the United States. One company, a major one, has pulled out of California because of the failure of that Legislature to look at this kind of issue.

"I believe that this is a good opportunity. The bill is a work in progress. There are a lot of issues with it. I will admit it's the 'bufo toad' to bills right now. But it will go to the Senate, and will hopefully come back to us so we can continue to work on this. But, we will be one of the first States in the country to have such a thing. And given the interest of major corporations becoming public purpose corporations, I think that it's wise that the Legislature continue to look at this issue. Thank you."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I rise with some reservations on this bill. It's not quite as good as it's been made out to be. It's in effect, a hybrid and an aberration, if you will, from the standard corporate laws, the standard nonprofits, which are public purpose corporations, which do have social purposes.

"This one is convoluting, I'm afraid, into more big government, and probably some kind of a 'voodoo economics' to make things on one particular group of the political spectrum look much better and more invasive. Thank you."

Representative Keith-Agaran rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Keith-Agaran's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in support of HB 1503 which provides Hawaii limited liability companies the ability to declare themselves as public purpose companies.

"This law does plow new ground and we should not be afraid of taking the lead on a new area.

"The purpose of the legislation is to provide any limited liability company that opts for a public purpose designation to exercise the right to exclude conferred by any patent in which the company has an interest for three public purposes: creating and retaining jobs, strengthening labor rights and enhancing environmental protection. This law creates a category akin to non-profit corporations and other entities that place the public interest ahead of making a profit, and in fact, for non-monetary objectives that support community building."

Representative Ching rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Bertram rose to speak in support of the measure, stating:

"Mr. Speaker, just in strong support. This is a relatively new concept, but I think it's one well worth exploring and investigating. We do need corporations whose bottom line is not just the bottom line, but is the community in which they serve. So, I applaud the Chair for actually putting forward a very progressive and forward thinking bill. My only hope is that this does get more discussion, and we do get a good bill out of this, because this is a good thing to have; corporations that are looking out for the community."

Representative M. Oshiro rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative M. Oshiro's written remarks are as follows:

"Mr. Speaker I rise in support of HB 1503 HD1, Relating to Limited Liability Companies.

"Mr. Speaker the purpose of this measure is to require any limited liability company that opts for a public purpose designation under this measure to exercise the right to exclude conferred by any patent in which the company has an interest for three public purposes: creating and retaining jobs, strengthening labor rights, and enhancing environmental protection. In addition to directly serving the public interest, creating a statutory requirement that a public purpose designated company use its patents to pursue specific non-monetary objectives may also increase the likelihood that the company will obtain a permanent injunction in court should its patent(s) be infringed upon [see [eBay v Mercexchange](#) 547 U.S. 388 (2006)], further increasing the company's ability to serve the public interest.

"Furthermore, the immediate demand for a public purpose designated LLC is twofold:

- 1) Public confidence in traditionally structured corporations and other corporate entities, which are designed to pursue short-term profits at the expense of all other considerations, is at an all-time low. Hawaii would be the first state in the nation to offer a public purpose LLC designation; and
- 2) Given the large number of U.S. corporate giants that are in either in bankruptcy or on the verge of filing, thousands of patents essential to rebuilding our economy and strengthening our nation's competitiveness, including a significant percentage of green technology patents, will be coming under some measure of public control. Hawaii's public purpose LLC structure will provide the ideal vehicle to redeploy the technologies covered by these patents back into the private sector in order to reenergize the innovative core of our national economy.

"For the reasons stated above, I support the measure."

Representative Belatti rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support with a few comments. Members, I'd just like to express my support for this. In the past, I've had some concerns with this type of legislation, but I think it is worthy of continued discussion.

"My concern is, and I hope what will be discussed as this moves forward, is that what is being created through this bill is a public purpose company that links the ability of this new type of corporate entity, to the noteworthy goals of job creation, strengthening labor rights and enhancing environmental protections.

"I think this is something innovative, and I applaud the introducer for introducing this bill, but I do hope that it will receive much more considerable attention, particularly in the areas of how this type of corporation may be subject to our tax laws, and other parts of State government. Thank you."

Representative Ward rose to respond, stating:

"Mr. Speaker, to be fair, if we want to strengthen labor rights nationally and internationally, why don't we say we want to strengthen stockholders' rights, nationally and internationally. That's where the skew is, and that's where I think we have to see through that it's not a balanced bill, unless it's adjusted according to what the previous speaker said is on one side, can be on both sides of the issue. Thank you."

The motion was put to vote by the Chair and carried, and H.B. No. 1503, HD 1, entitled: "A BILL FOR AN ACT RELATING TO LIMITED LIABILITY COMPANIES," passed Third Reading by a vote of 48 ayes, with Representatives Berg, Finnegan and Takai being excused.

At 12:36 o'clock p.m., the Chair noted that H.B. No. 1503, HD 1, passed Third Reading.

"But, what's more concerning is that it removes the requirement that a fee can be changed within a department, and no longer be subject to the approval of the Governor. I think we need those checks and balances. If the Legislature's not going to talk about just the fees, we also need the Governor to be the check on the fees that we're going to raise on the people."

Representative Ching rose in support of the measure with reservations and asked that the remarks of Representative Pine be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Marumoto rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I question this measure. I will vote for it, with reservations, but it allows increases without the consent of the Board of Regents, as far as the University of Hawaii fees. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1728, HD 1, entitled: "A BILL

FOR AN ACT RELATING TO FEES," passed Second Reading, and was placed on the calendar for Third Reading with Representatives Berg, Finnegan and Takai being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 741) recommending that H.B. No. 1741, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

"Yes, support with reservations on Stand. Com. Rep. No. 741. What this bill does is, it suspends the portions of the Conveyance Tax transmitted to the Land Conservation Fund. It also reduces the portions of the Conveyance Tax transmitted to the Rental Housing Trust Fund, as well as reduces portions of the Conveyance Tax to the Natural Area Reserve Fund.

"We went through, several Legislatures ago, to create this type of appropriation to these different areas because we believe the environment was something we should take more seriously, as well as taking seriously, providing affordable housing to the people of Hawaii. So, I understand we're trying to balance the budget, but I think this is an area that we should try to avoid as much as possible."

Representative Thielen rose in support of the measure with reservations and asked that the remarks of Representative Pine be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Wooley rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Wooley's written remarks are as follows:

"In these tough economic times, the Legislature must turn over every rock in State government and look for ways to balance our budget. And as a member of the Finance Committee, I have supported many bills that I dislike because I know that we need to put all potential options on the table. I believe this bill, however, is 'penny wise and pound foolish', as it diverts dwindling funds (the Conveyance Tax will already fall between 50-60 percent as a result of the economic downturn) and small amounts of money into the general fund at the expense of critical programs that protect our economy, our health, and our safety.

"Special funds are not the best way for government to support programs. However, without this funding, resources for affordable rental housing, private-public partnerships that protect our watersheds (i.e., our drinking water), and youth programs will disappear. In addition, programs that prevent invasive species from entering the State or becoming established and efforts to protect land for agricultural, conservation and cultural use will end at a critical time. In tough times, we need to be extra vigilant to make sure we don't jeopardize our future options, particularly when we can make a big difference at cut rate prices. Testimony against this bill also identified a significant number of critical jobs that will be eliminated if this bill becomes law."

Representative Ching rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Marumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative C. Lee rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Belatti rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1741, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE CONVEYANCE TAX," passed Second Reading, and was placed on the calendar for Third Reading with Representatives Berg, Finnegan and Takai being excused.

Representative M. Oshiro, for the Committee on Finance presented a report (Stand. Com. Rep. No. 742) recommending that H.B. No. 1744, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative McKelvey rose to speak in opposition to the measure, stating:

"Thank you very much, Mr. Speaker. I'll reserve my comments for Third Reading, but please register a 'no' vote for me."

Representative Luke rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Souki rose to speak in support of the measure with reservations, stating:

"Yes, Mr. Speaker. On Stand. Con. Rep.. 742, with reservations, and I'll reserve my comments for Third Reading."

Representative C. Lee rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Chang rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ching rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Ching's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in opposition to H.B. 1744 - Relating to Transient Accommodation Tax. I am concerned this bill might hurt the counties, and in turn they might have to raise property taxes to make up for lost revenue. As the Hawaii Council of Mayors states in their testimony, "The counties provide the critical security, transportation, water and sewer infrastructure." It is important to continue sharing revenue with the counties so they are able to provide the necessary services. Thank you."

Representative Belatti rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Bertram rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Coffman rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, a 'no' vote with a small comment. Because I love my Neighbor Island guys, but I don't serve at your pleasure. I serve at the pleasure of my district. But this bill is for you guys, because it's going to take \$100 million from your islands. This is the TAT Tax, which we are pulling out of counties, and putting in the State coffers.

"This is bad policy. I know we got to have everything on the table, but this goes to the edge and off, and too far into the deep, Mr. Speaker. So, I'm voting 'no.' Thank you."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Hanohano rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Carroll rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Nakashima rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Aquino rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Sagum rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Keith-Agaran rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Morita rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Thielen rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Pine rose to speak in support of the measure, stating:

"In support. Just thought I'd help the Finance Chair on one of these. You spend 15, 16, to 17 hours together, you realize how tough the budget's going to be for us this year. And really, the one good thing that this bill does, is take away the super priority given to the counties, and allows the State to prioritize allocation amongst the programs that serve the people of Hawaii through the State.

"So, it's a good discussion that will continue. And in the end, we'll decide whether this is the way to balance the budget."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1744, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE TRANSIENT ACCOMMODATIONS TAX," passed Second Reading, and was placed on the calendar for Third Reading with Representatives Belatti, Bertram, Carroll, Ching, Hanohano, Luke, McKelvey and Ward voting no, and with Representatives Berg, Finnegan and Takai being excused.

"Thank you, Mr. Speaker. I rise in opposition to H.B. 1748 - Relating to Insurance Premium Taxes. I am concerned this bill might hurt consumers. Hawaii already has one of the highest life insurances premium tax rates in the nation and I believe we shouldn't be increasing taxes when the

economy is not growing. I believe this bill might force the insurance companies to raise new policy rates, which could lead to more uninsured, or there is a chance the companies could go out of business.

"The National Association of Insurance and Financial Advisors states in their testimony that "Increasing the GTE rate to 4.265% will only increase the cost of the life insurance contract on new life insurance policies to the consumer because it is the consumer who will bear that increase in the tax rate because the insurance companies will include the tax into the set premium charge." Thank you."

Representative Marumoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Pine rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative B. Oshiro moved that the report of the Committee be adopted, and that H.B. No. 355, HD 1, pass Third Reading, seconded by Representative Evans.

Representative Cabanilla rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Cabanilla's written remarks are as follows:

"This bill simply asks for two measures. First, the bill asks that late fees cannot exceed more than 20% of the monthly maintenance fee. There are associations in Hawaii that currently charge a fine of as much as fifty percent of association fees if the condominium owner is more than ten days late. With these difficult economic times, this added fee can place untenable hardship on the owner.

"The second provision of this bill is to require associations to give owners ten days notice of an action or possible action to turn matters over to an attorney. This should be done by both postal and electronic mail – in the event that the owner is out of town.

"Mr. Speaker, the compelling necessity for this type of legislation is that, in many cases, the condominium associations, contrary to standard fair credit practices, are conglomerating late occurrences instead of treating each late occurrence separately. They are counting the 10 day notification period of a previous late occurrence as credit towards a subsequent late occurrence. This decreases the waiting and notification requirements before they are allowed to refer the case to an attorney. Condominium associations need to be regulated in the same manner as any other debt collector.

"Attorney's fees are very costly and can contribute to a property going into foreclosure.

"These are simple measures to place in the statute, however they will increase fairness to condominium owners."

Representative Pine rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Pine's written remarks are as follows:

"Mr. Speaker, I rise in strong support of this measure, Stand. Com. Rep. No. 770, HB 355, HD1.

"Currently, each condominium association has the autonomy to assess fines, fees, and collection mechanisms for those within its membership that are in arrears. This bill does not erode that autonomy on the collection process, but rather defines parameters to protect condominium owners from egregious financial penalties for merely being late in their maintenance payments.

"In these economic times, association boards have the means to assess attorney fees and fines without any cap or financial ceiling for a member who may be late in paying their maintenance fee by one day.

"In Ewa Beach for example, a condominium association charges \$115 a month for maintenance fees and if the member is late by one day- is assessed a fine of greater than 50% of that fee- that amount being \$60 and attorney's fees of \$200 applied.

"Albeit associations have the authority to set their own fining policies, we need to ensure homeowners have the ability to stay current on their financial obligations and offer remedy without ramifications that penalize them into homelessness.

"A 20% cap on the amount of the late fee/fine is necessary to ensure owners in financial difficulties have the capability to repay their debts. The bill also addresses the added burden of attorney fees being assessed after one- day in arrears. A ten- day holding off period or stay on attorney's fees will assist homeowners pay off their debt and remain in their homes.

"Mr. Speaker, I strongly urge my colleagues to support HB355 HD1 to help define and guide associations into preserving a sound collection process without harming those trying to repay their debts."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 355, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CONDOMINIUMS," passed Third Reading by a vote of 48 ayes, with Representatives Berg, Finnegan and Takai being excused.

Representative Pine rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Pine's written remarks are as follows:

"Mr. Speaker, I rise in strong support of House Bill 875. The purpose of this bill is to enhance options for resolving condominium disputes by extending the Condominium Dispute Resolution Pilot Program for another two years.

"The pilot program, set forth in sections 514A-121.5 and 514B-161, Hawaii Revised Statutes, and set to expire on June 30, 2009, was established to facilitate quick and economical resolutions of disputes between condominium owners and management.

"If HB875 were to not advance, owners would still be required to pay a \$2 per year tax into the Condominium Education Trust Fund without being in receipt of the very services the tax was supposed to sustain.

"Mr. Speaker, I cannot as an elected official condone the collection of a tax assessed upon one segment of the population that happens to own a condominium unit and offer them nothing of value in return for that tax. Our founding fathers coined such maneuver, "taxation without representation." Mr. Speaker, I strongly urge my colleagues to support HB875."

The motion was put to vote by the Chair and carried, and H.B. No. 875, entitled: "A BILL FOR AN ACT RELATING TO CONDOMINIUMS," passed Third Reading by a vote of 48 ayes, with Representatives Berg, Finnegan and Takai being excused.

H.B. No. 1554:

Representative B. Oshiro moved that H.B. No. 1554, pass Third Reading, seconded by Representative Evans.

Representative Har rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Har's written remarks are as follows:

"Mr. Speaker, I stand in support of Standing Committee Report No. 660, House Bill 1554, Relating to the Hawai'i Community Development Authority. This measure allows the Chairperson of the Department of Hawaiian Home Lands (DHHL) and the Director of the City and County Department of Planning and Permitting (DPP) to designate a representative to serve on the Hawai'i Community Development Authority, which will make it easier to obtain quorum and allow important decisions to be made without delay, without depriving the representation of DHHL and DPP. This is a small technical amendment, but without which crucial development decisions would be delayed unnecessarily. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and H.B. No. 1554, entitled: "A BILL FOR AN ACT RELATING TO HAWAII COMMUNITY DEVELOPMENT AUTHORITY," passed Third Reading by a vote of 48 ayes, with Representatives Berg, Finnegan and Takai being excused.

H.B. No. 135:

Representative B. Oshiro moved that H.B. No. 135, pass Third Reading, seconded by Representative Evans.

Representative B. Oshiro rose to speak in support of the measure, stating:

"Mr. Speaker, I rise in support. Just very briefly, I just want to say that sometimes the bill stands for what it is, and sometimes a bill is actually

symbolic for a democracy. I introduced this bill on behalf of the 5th graders at Pearl Ridge Elementary. And so, I really want to thank them for participating in our democratic process."

Representative McKelvey rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support, and I just want to say that I hope this bill has wings and flies, thank you."

Representative Manahan rose to speak in support of the measure, stating:

"In strong support. Strong support. I wanted to commend the Majority Leader for taking this initiative. I thought it was a really good lesson for the testifiers who came from Pearl Ridge Elementary. They certainly educated the Committee, and I learned something new about the *Pulelehua*, the Kamehameha Butterfly, and it's certainly a worthy measure. Thank you."

Representative Ching rose to speak in support of the measure, stating:

"In support, and I would be remiss if I didn't also lend my support, as someone who used to teach at an elementary school. Truly, when the children do see that something's being done on behalf of them now, they have an interest and a stake in the Legislature. So, you are doing something very powerful. Thank you."

The motion was put to vote by the Chair and carried, and H.B. No. 135, entitled: "A BILL FOR AN ACT RELATING TO THE STATE INSECT," passed Third Reading by a vote of 48 ayes, with Representatives Berg, Finnegan and Takai being excused.

It's just to recognize the approximately 3,000 victims of the 9/11 terrorist attacks, and to also recognize the great heroes in the aftermath of the attack, as they tried to save and rescue lives after this most horrific incident in our history.
