



THIRTY-FIFTH DAY

Tuesday, March 24, 2009

The House of Representatives of the Twenty-Fifth Legislature of the State of Hawaii, Regular Session of 2009, convened at 12:07 o'clock p.m., with Vice Speaker Magaoay presiding.

The invocation was delivered by Bishop Scott J. Bradshaw of The Church of Jesus Christ Latter Day Saints, after which the Roll was called showing all members present with the exception of Representatives M. Oshiro and Takai, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Fourth Day was deferred.

Representative Keith-Agaran rose in support of the measure with reservations and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Keith-Agaran's written remarks are as follows:

"Thank you, Mr. Speaker. I have reservations with a portion of SB 1311, SD 1, Relating to Aquatic Resources.

"I am concerned about granting the University of Hawai'i a blanket and broad permit exemption for repair and maintenance of State land and buildings at the Hawaii Marine Laboratory Refuge on Moku o Lo'e, also known as Coconut Island. This exemption is neither needed nor prudent.

"Hawaii is an Ocean State and we owe it to future generations to be attentive stewards of our precious nearshore aquatic ecosystem. For many of our residents, the Pacific Ocean is our main place of recreation as well as a source of spiritual sustenance. Many of our families still depend on nearshore resources for subsistence and cultural purposes.

By exempting the University of Hawai'i from following the proper procedures in place for any other user of State fast and submerged lands puts at risk our marine life. It's a fact that the invasive algae species that have overtaken the coral reefs in Kāne'ohe Bay have been traced to samples introduced by researchers from the University. These foreign species remain a challenge and cause problems for the Windward O'ahu's nearshore areas. I certainly hope the University of Hawai'i staff and researchers of today take more than a clinical appreciation of our islands and hold a better and more profound admiration for our native ecosystem. I'm sure they will be vigilant in preventing the destruction or removal of corals or other marine life and taking proper precautions against the introduction of alien species.

"But the exemption is simply not needed.

"I'm not persuaded that the University somehow needs to avoid regulatory oversight for the broad and undefined category of repair and maintenance. It troubles me that the University would seek a broad exemption when the existing regulations already provide exemptions that have been established through rulemaking and the experience of DLNR. Since the mid-1990s, the Department of Land and Natural Resources (DLNR) has employed a sliding scale of regulatory requirements for work in the conservation district. If the proposed work is truly minor repair and maintenance, DLNR's Office of Conservation and Coastal Lands (OCCL) can process a simple site plan approval or even employ a proper and considered categorical exemption in the existing rules. Further, work that is more involved may still only require a permit processed through OCCL. Only profound changes to the landscape would require a full Conservation District Use Permit and a Land Board hearing.

"For these concerns, please record my vote with reservations."

Representative Shimabukuro's written remarks are as follows:

"Mr. Speaker, I rise to speak in strong support of SB 417, which establishes guidelines for Medicaid reimbursement to hospitals and facilities with long-term beds. The bill also makes appropriations for safe house programs for at-risk youth, as well as for emergency services at Federally Qualified Health Centers.

"While I speak in support of the bill in its entirety, I speak with special concern for my many constituents whose health and well-being have long depended on emergency services offered by our non-profit federally qualified health center. The Wai'anae Coast Comprehensive Health Center (WCCHC)—along with other community health centers in low-income areas throughout the state that will benefit from this legislation—has thus far been able to keep its emergency room open 24 hours a day, 365 days a year. Without help from the Legislature, this around-the-clock service may not be able to continue.

"Our Committees on Human Services and Health heard compelling testimony submitted by the CEO of the Wai'anae Center. Of the \$1.8 million needed to operate emergency services between midnight and 8 a.m., he pointed to a \$332,000 shortfall for the coming fiscal year. As a result, the Committees amended SB 417 to include an unspecified appropriation to help WCCHC and other health centers maintain current levels of service.

"During all my years as a legislator, even when times were better, I have heard the same cries for help. Each year, WCCHC has had to come to us and beg for emergency services funding. Somehow, whether by tapping into Rainy Day funds or other sources, the Legislature has risen to the occasion and managed to keep these critical services from being shut down. This year, the need is greater than ever.

"I urge my colleagues to join me in supporting this bill, which gives some measure of hope to those who depend so heavily on our community health centers."
