Wednesday, March 25, 2009

The House of Representatives of the Twenty-Fifth Legislature of the State of Hawaii, Regular Session of 2009, convened at 12:05 o'clock p.m., with the Speaker presiding.

Representative Ching rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Ching's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in opposition to S.B. 777 - Relating to Comprehensive Sexuality Health Education. I continue to believe that this bill is unnecessary because the current sexual education curricula being taught by the State is accurate and appropriate. The Department of Health states in their testimony that, "Information currently provided by State-funded DOH programs regarding sexual health education, family planning, pregnancy counseling, and sexually transmitted diseases, including Human Immunodeficiency Virus and Acquired Immune Deficiency Syndrome, is medically accurate, based on scientific fact, and is age appropriate. This bill is unnecessary because as part of the contracting process, program materials are reviewed by DOH on a regular basis, and inaccurate information would be corrected at this time."

"The Hawaii Family Forum, which is a non-profit, pro-family education organization committed to preserving and strengthening families in Hawaii, states, "S.B.777 is an unnecessarily punitive measure, which will de-fund successful local abstinence programs for Hawaii's youth." I agree with the Hawaii Family Forum and would like to see the continuation of such programs as, "Try Wait." Catholic Charities Hawaii has operated this successful federally funded abstinence program, which is a medically accurate abstinence-only program. Thank you."

Representative Bertram rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. "I speak as a proponent of a "global solution" to the OHA issue. This bill is but a small step towards that goal.

"My reservations stem from the Senate intent to transfer Mauna Kea and other properties to OHA, and although subsequent HDs have not reflected this desire, the original idea can always re-emerge in conference drafts.

"Regarding the properties of Kaka'ako Makai, the testimony of the Attorney General pointed out that OHA's unilateral ability to pick and choose means that the State could be left with property that is fragmented rather than contiguous, and substantially de-valued by the selection. We should be more careful with the land owned by citizens and taxpayers."

Representative Ching: "Thank you, Mr. Speaker. Mr. Speaker, tomorrow, March 26, we will celebrate Prince Jonah Kuhio Kalaniana'ole Day. He was born in 1871, the Prince of the Reigning House of Kalaukua, and Hawaii's second Delegate to Congress, and he was called Ke Ali'i Maka 'Ainana, Prince of the People. Citizen Prince. In line to become the king of the Hawaiian Monarchy, had it continued.

"Upon the overthrow in the 1800s, a year later, he joined Native Hawaiians and American sympathizers, in organizing what would become an unsuccessful rebellion against the newly formed Republic of Hawaii that would lead to his imprisonment.

"And upon his release, he left Hawaii, traveled to Europe, Africa, joined the British Army to fight the Second Boer War, before returning home to Hawaii's new political scene.

"And in 1901, Prince Kuhio Kalaniana'ole joined the Republican Party, and was credited as starting the Republican Party in Hawaii, whereas his brother, David Kawananakoa started the Democrat Party. And as the Party's U.S. Congressional Delegate won a sweeping victory, he would serve from 1903 to his death in 1922.

"He is buried at Mauna Ala, the Royal Mausoleum, in Nu'uano, where there will be a ceremony, tomorrow at 9 a.m. In attendance will be Princess Abigail Kekaulike Kawananakoa. Thank you."
