## FORTIETH DAY

Thursday, April 2, 2009

The House of Representatives of the Twenty-Fifth Legislature of the State of Hawaii, Regular Session of 2009, convened at 12:05 o'clock p.m., with the Speaker presiding.

The invocation was delivered Reverend Bob Nakata of the Kahalu'u United Methodist Church, after which the Roll was called showing all members present with the exception of Representatives Cabanilla, M. Oshiro, Souki and Takai, who were excused.

On motion by Representative Evans, seconded by Representative Pine and carried, reading of the Journals was dispensed with and the Journals of the Twenty-Fourth and Twenty-Fifth Days were approved. (Representatives M. Oshiro, Souki and Takai were excused.)

## GOVERNOR'S MESSAGES

The following message from the Governor (Gov. Msg. No. 278) was received and announced by the Clerk and was placed on file:

Gov. Msg. No. 278, dated March 30, 2009, transmitting a proposed bill draft for immediate passage to amend the FY 09 Executive Budget (Act 213, SLH 2007, as amended by Act 158, SLH 2008). The draft includes:

- Departmental requests for federal stimulus funds in the American Recovery and Reinvestment Act of 2009 (ARRA) for FY 09. The draft also contains corresponding general fund reductions to certain programs that receive offsetting federal funding available under the ARRA to help address the State's budget shortfall in FY 09.
- Non-ARRA related adjustments to appropriate increased federal TANF funding that Hawaii recently qualified for in FY 09. This is necessary because appropriation of the TANF funds is a federal requirement.
- Requests for additional FY 09 funding for HTH 420, Adult Mental Health – Outpatient program, of \$10 million, \$1.86 million in ARRA Federal Medical Assistance Percentage (FMAP) through the Department of Human Services (DHS) funds and \$8.14 million in general funds, and for HTH 210, Hawaii Health Systems Corporation, of \$14 million in general funds to meet program requirements for FY 09.

However approximately 60% of the population in the healthcare system suffering from chronic conditions such as diabetes and cardiovascular disease would not be suffering from these conditions if they adopted a regular exercise regimen and ate more healthy foods.

"Instead of only treating illnesses after the fact, we should be proactive and assist in the prevention of these disabling conditions before they occur. Incorporating sustainable wellness programs into our healthcare system will not only lower our healthcare costs, but ensure that our citizens lead a more active and healthy life."

However, DHS is already thoroughly audited by the federal government in order to maintain its current level of federal funding. Moreover, under its current leadership, DHS has demonstrated a propensity for finding further sources of federal revenue. Under Director Lillian Koller, DHS has brought \$175 million of new federal funding into the Department's budget.

"As DHS has already demonstrated that it is fiscally sound, I believe this Resolution is unneeded and would be a waste of State resources, especially given the limits of our means in this budgetary period. Thus I submit my reservations.

"Thank you for this opportunity to offer my reservations to this measure."

This bill would require the Statewide Transportation Council to comply with county transportation-related plans, county general plans, and all community, development, or community development plans adopted pursuant to the county general plan, to the extent that compliance does not affect the receipt of federal funds.

"Improving coordination between the State and counties is critical to ensure our major backbone infrastructure is planned, funded and constructed in a timely basis. As transportation funding begins to shrink at the federal level, it is important to coordinate our efforts at the State and county levels to maximize our returns.

"While the Island of Oahu has the Oahu Metropolitan Planning Organization (OMPO) to set its priorities, the Department of Transportation (DOT) sets the Statewide Transportation Improvement Program, or STIP, for the Neighbor Islands. This bill will ensure that the DOT will take into account county transportation and general plans to ensure consistency and to eliminate conflict with county plans when the STIP is implemented. Furthermore, by providing consistency between the STIP and county plans, Hawai'i will have more effective transportation systems that will better meet the transportation needs of Hawai'i's citizens.

"Mr. Speaker, as we know Hawai'i has a finite amount of land, and our development decisions will continue to affect us as our population continues to grow which is why I continue to advocate for smart growth development. SB 715, HD 1, will ensure that our transportation-related plans will be cohesive and comprehensive.

"Finally, I would like to thank Senator English for introducing this Senate bill on my behalf. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 715, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TRANSPORTATION," passed Third Reading by a vote of 50 ayes, with Representative Takai being excused.

By unanimous consent, consideration of Stand. Com. Rep. No. 1426 on S.B. No. 848, HD 1 was deferred and in accordance with Article III, Section 15 of the Constitution of the State of Hawaii, printed copies of S.B. No. 848, HD 1, were made available to the members of the House.

Representative Ito, for the Committee on Water, Land, & Ocean Resources presented a report (Stand. Com. Rep. No. 1427) recommending that S.B. No. 1195, SD 1, HD 1, as amended in HD 2, pass Third Reading.

By unanimous consent, consideration of Stand. Com. Rep. No. 1427 on S.B. No. 1195, SD 1, HD 2 was deferred and in accordance with Article III, Section 15 of the Constitution of the State of Hawaii, printed copies of S.B. No. 1195, SD 1, HD 2, were made available to the members of the House.

#### SUSPENSION OF RULES

On motion by Representative B. Oshiro, seconded by Representative Evans and carried, the rules were suspended for the purpose of reconsidering action previously taken in disagreeing to amendments made by the Senate to a certain House bill. (Representatives Cabanilla and Takai were excused.)
