## FORTY-SEVENTH DAY

Thursday, April 16, 2009

The House of Representatives of the Twenty-Fifth Legislature of the State of Hawaii, Regular Session of 2009, convened at 12:06 o'clock p.m., with Vice Speaker Magaoy presiding.

Representative B. Oshiro moved that the reports of the Committee be adopted, and that H.R. No. 270, HD 1, and H.C.R. No. 298, HD 1, be adopted, seconded by Representative Evans.

Representative Finnegan rose in support of both measures and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Finnegan's written remarks are as follows:

"Mr. Speaker, I rise in strong support of these measures. The unfortunate failure of our Government in the past to keep promises made to a quarter of a million Filipinos who answered our call to battle in World War II is a scar on our nation's past. The least we can do is to extend what we can to the beloved family members of those who fought so valiantly and diligently on our behalf, to simply expedite immigration visas to reunify families that paid a price literally in blood for the freedoms that we have today. I strongly urge the United States President, Senate, and House of Representatives to expedite these immigration visas."

Representative McKelvey rose to speak in support of both measures, stating:

"Thank you very much, Mr. Speaker. In support for both 1752 and 1753, and just some brief comments. Members, there's been legislation introduced in Congress to allow the Veterans of the World War II to be able to be reunited with their family members. These are very timely Resolutions, because hopefully by sending it up there now, it will give our Congressional Delegations some added steam power to get it through Congress and to President Obama's desk. So, again, thank you for all your support, Members. Mahalo."

Representative Cabanilla rose to speak in support of both measures, stating:

"In support, Mr. Speaker. And, on behalf of myself and Representative Mizuno, who introduced a similar piece of legislation last year, we stand in full support."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R.
