2 SECTION 3. There are appropriated or authorized from the  
3 sources of funding indicated below to collective bargaining  
4 statewide (BUF 102) the following sums, or so much thereof as  
5 may be necessary, to fund for fiscal biennium 2015-2017, the  
6 salary increases and other cost adjustments authorized by  
7 chapter 89C, Hawaii Revised Statutes, for state officers and  
8 employees who are excluded from collective bargaining and belong  
9 to the same compensation plans as those officers and employees  
10 within collective bargaining unit (5):

2 funding indicated below to health premium payments (BUF 761) the  
3 following sums, or so much thereof as may be necessary, to fund  
4 for fiscal biennium 2015-2017, the Hawaii employer union health  
5 benefits trust fund costs in the agreement negotiated with the  
6 exclusive bargaining representative of collective bargaining  
7 unit (5):

10 SECTION 6. Funds appropriated by this part shall be

15 SECTION 7. Salary increases and cost adjustments provided  
16 in this Act for any officer or employee whose compensation is  
17 paid, in whole or in part, from federal, special, or other funds  
18 shall be paid wholly or proportionately, as the case may be,  
19 from the respective funds.

20 SECTION 8. Funds appropriated or authorized by this Act  
21 that are not expended or encumbered by June 30, 2016, and



1 June 30, 2017, of the respective fiscal years, shall lapse as of  
2 those dates.

3 SECTION 9. This Act, upon its approval, shall take effect  
4 on July 1, 2015.
