A BILL FOR AN ACT

RELATING TO IRRIGATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Reliable irrigation systems are the lifelines
2 of Hawaii's agricultural industry. To ensure that Hawaii's
3 agricultural crops receive a steady and dependable supply of
4 water, sufficient funding is needed to maintain and improve
5 Hawaii's irrigation systems. Increasing and extended water
6 droughts have highlighted the need for the repair and
7 maintenance of the irrigation systems in the State.

8 The purpose of this Act is to appropriate moneys for
9 maintenance and improvements to the Peekauai ditch irrigation
10 system located on the island of Kauai.


11 SECTION 2. There is appropriated out of the general
12 revenues of the State of Hawaii the sum of \$10,000 or so much
13 thereof as may be necessary for fiscal year 2015-2016 for the
14 purpose of maintenance and improvements to the Peekauai ditch
15 irrigation system located on the island of Kauai, also known as
16 Menehune ditch, and all appurtenances.



1 The sum appropriated shall be expended by the department of
2 agriculture for the purposes of this Act.

3 SECTION 3. This Act shall take effect on July 1, 2015.
