### A BILL FOR AN ACT

RELATING TO HISTORIC PRESERVATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 6E-8, Hawaii Revised Statutes, is
 amended to read as follows:

3 "§6E-8 Review of effect of proposed state projects. (a) 4 Before any agency or officer of the State or its political 5 subdivisions commences any project which may affect historic 6 property, aviation artifact, or a burial site, the agency or 7 officer shall advise the department and allow the department an 8 opportunity for review of the effect of the proposed project on 9 historic properties, aviation artifacts, or burial sites, 10 consistent with section 6E-43, especially those listed on the 11 Hawaii register of historic places. The proposed project shall 12 not be commenced, or if it has already begun, continued, until 13 the department has given its written concurrence. If: 14 (1)The proposed project consists of corridors or large

3 the department may give its written concurrence based on a
4 phased review of the project; provided that there shall be a

8 The department shall provide written concurrence or non-9 concurrence within ninety days after the filing of a request 10 with the department. The agency or officer seeking to proceed with the project, or any person, may appeal the department's 11 12 concurrence or non-concurrence to the Hawaii historic places 13 review board. An agency, officer, or other person who is 14 dissatisfied with the decision of the review board may apply to the governor, who may take action as the governor deems best in 15 16 overruling or sustaining the department.

17 (b) The department of Hawaiian home lands, prior to any
18 proposed project relating to lands under its jurisdiction, shall
19 consult with the department regarding the effect of the project
20 upon historic property or a burial site.
