### A BILL FOR AN ACT

RELATING TO PHARMACIES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 461-9, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "\$461-9 Pharmacist in charge; pharmacy personnel[-];
- 4 staffing requirements. (a) A registered pharmacist shall be in
- 5 personal and immediate charge of the pharmacy and personnel
- 6 employed in the pharmacy. Temporary absences of the registered
- 7 pharmacist shall be unlawful except for periods of time and
- 8 under circumstances as authorized under the rules of the board.
- 9 During any absence of the registered pharmacist, prescriptions
- 10 may not be filled, compounded, or received by telephone and no
- 11 drugs shall be sold; provided that this shall not preclude the
- 12 sale at those times of things that might be sold were the
- 13 pharmacy a store not subject to this chapter. No person other
- 14 than a registered pharmacist or a pharmacy intern under the
- 15 registered pharmacist's immediate supervision shall fill or
- 16 compound prescriptions except as provided by subsection (c).

1	(b) No person shall practice as a pharmacy intern without
2	having first obtained a permit from the board. The board shall
3	adopt rules pursuant to chapter 91 defining the functions of a
4	pharmacy intern, establishing the requirements to be met by an
5	applicant for a pharmacy intern permit, and specifying the
6	duration of the permit and the procedures for the immediate
7	supervision of the pharmacy intern by a registered pharmacist.
8	(c) A pharmacy technician may be employed to assist the
9	registered pharmacist under rules adopted by the board pursuant
10	to chapter 91 that define the qualifications and functions of
11	the pharmacy technician and provide the procedures for control
12	and supervision by a registered pharmacist.
13	(d) No registered pharmacist shall be required to engage
14	in the practice of pharmacy when the pharmacy is open to the
15	public if no pharmacy intern, pharmacy technician, or pharmacy
16	employee is available to assist the registered pharmacist at all
17	times; provided that if the pharmacy is located within an
18	independent retail establishment the registered pharmacist shall
19	be required to engage in the practice of pharmacy if no employee
20	of the retail establishment is available to assist the
21	registered pharmacist at all times. This subsection shall not

- apply to a registered pharmacist engaging in the practice of 1
- pharmacy at an on-site pharmacy in an institutional facility." 2
- 3 SECTION 2. Statutory material to be repealed is bracketed
- and stricken. New statutory material is underscored. 4
- SECTION 3. This Act shall take effect upon its approval. 5
