A BILL FOR AN ACT

RELATING TO STATE ACQUISITION OR DEVELOPMENT OF REAL PROPERTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that a significant
- 2 proportion of the State's public employee work force is
- 3 concentrated in downtown Honolulu. As many state agencies and
- 4 employees are outgrowing existing office space and aging
- 5 infrastructure, there is a pressing need for the State to
- 6 identify and acquire or build additional office space in urban
- 7 Honolulu to accommodate state governmental agencies and offices.
- 8 This Act proposes consideration of an alternative to
- 9 constructing the Liliha Civic Center through purchase of an
- 10 office building of a comparable size, with the cost of acquiring
- 11 the building at less than one-third that of constructing the
- 12 Liliha Civic Center.
- 13 The purpose of this Act is to appropriate funds to
- 14 identify, plan, and acquire or build upon real property in urban
- 15 Honolulu to provide office space for state governmental agencies
- 16 and offices.
- 17 SECTION 2. The governor's office, department of the
- 18 attorney general, department of land and natural resources,



- 1 department of accounting and general services, and department of
- 2 budget and finance may enter into negotiations for the purchase
- 3 of Ali'i Place; provided that any deal reached within the next
- 4 two years shall include the continuance of the building's
- 5 existing property management firm.
- 6 SECTION 3. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$500,000 or so much
- 8 thereof as may be necessary for fiscal year 2015-2016 and the
- 9 same sum or so much thereof as may be necessary for fiscal year
- 10 2016-2017 to pay the costs of the State's due diligence,
- 11 appraisal, closing costs, consultant services, legal services,
- 12 and other costs incurred by the department of land and natural
- 13 resources in connection with the transaction to acquire the
- 14 leasehold interest in the land identified as TMK (1) 2-1-017-
- 15 008-0000 and to acquire the building thereon.
- 16 The sums appropriated shall be expended by the department
- 17 of land and natural resources for the purposes of this Act.
- 18 SECTION 4. The department of accounting and general
- 19 services is authorized to perform due diligence in connection
- 20 with the transaction to acquire the leasehold interest in the
- 21 land identified as TMK (1) 2-1-017-008-0000.

- 1 SECTION 5. The department of land and natural resources,
- 2 in conjunction with the department of accounting and general
- 3 services, shall submit a joint report on their progress to the
- 4 legislature no later than twenty days prior to the convening of
- 5 the regular session of 2016.

SECTION 6. This Act shall take effect on July 1, 2015.
