A BILL FOR AN ACT

RELATING TO NURSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

	DE IT ENACTED DI THE LEGISLATURE OF THE STATE OF HAWAII:
1	SECTION 1. The legislature finds that the requirement of
2	all candidates for an initial nurse license to pass a national
3	examination has resulted in the consistent practice of quality
4	health care services administered to the public. This
5	examination safeguards the quality of health care practices by
6	ensuring that each candidate possesses the minimum competencies
7	necessary for a newly licensed, entry-level registered or
8	practical nurse to perform work safely and effectively. Despite
9	the clear benefits of this safeguard, continuing competency
10	requirements are not currently instituted for nurse licensure
11	renewal applications in the State.
12	The legislature also finds that in today's health care
13	environment, knowledge of the latest developments in the
14	profession is a crucial means by which nursing duties are safely
15	and effectively fulfilled. New health care systems are emerging
16	and redoubling the challenge of licensure boards to assure
17	consumers that licensed nurses shall remain competent for the

duration of their practice. The legislature further finds the

- 1 most efficient means to ensure patient safety is to require
- 2 Hawaii-licensed nurses to complete continuing competency
- 3 requirements prior to any application for license renewal,
- 4 restoration, or reinstatement.
- 5 Accordingly, the purpose of this Act is to require all non-
- 6 exempt licensed registered nurses and licensed practical nurses
- 7 to complete continuing competency requirements prior to the
- 8 submission of an application for license renewal, restoration,
- 9 or reinstatement, beginning on July 1, 2017.
- 10 SECTION 2. Chapter 457, Hawaii Revised Statutes, is
- 11 amended by adding two new sections to be appropriately
- 12 designated and to read as follows:
- "§457- Continuing competency requirements; exemptions;
- 14 extensions; records retention; audit. (a) Beginning July 1,
- 15 2017, with the renewal of the licensing biennium, and every
- 16 biennial renewal thereafter, each registered nurse and practical
- 17 nurse licensee shall have completed one of the learning activity
- 18 options recognized by the board within the two-year period
- 19 preceding the renewal date, in addition to the requirements of
- 20 section 457-9.

1	(b)	The following nurses shall be exempt from the
2	continuin	g competency requirements:
3	(1)	Registered nurses licensed in this State who also
4		maintain active advanced practice registered nurse
5		licenses in accordance with this chapter and have a
6		current national certification approved by the board;
7	(2)	Registered nurses and practical nurses licensed in
8		this State who also maintain current national
9		certification, approved by the board, in their
10		practice role; or
11	(3)	A licensee who graduated or completed pre-licensure
12		requirements from an accredited nursing program
13		recognized by the board within twelve months prior to
14		the renewal date of the licensee's first license
15		renewal period.
16	<u>If a</u>	licensee graduated or completed pre-licensure
17	requireme	nts from an accredited nursing program more than twelve
18	months bu	t less than two years prior to the renewal date, the
19	registere	d nurse or practical nurse licensee shall be required
20	to obtain	fifteen contact hours of continuing education, one
21	semester	credit of post-licensure academic education related to

1	nursing p	ractice from an accredited nursing program, completion
2	of a boar	d-recognized nurse residency program, or other learning
3	activity	options from an approved provider recognized by the
4	board pri	or to the first renewal period.
5	(c)	The board may extend the deadline for compliance with
6	the conti	nuing competency requirements and shall consider each
7	case on a	n individual basis. Prior to the expiration of the
8	license,	a nurse licensee may submit a written request for an
9	extension	and any documentation requested by the board to
10	substantiate the reason for the extension of the deadline for	
11	complianc	e with the continuing competency requirements of this
12	section,	based on the following circumstances:
13	(1)	Illness, as certified by a physician or osteopathic
14		physician licensed under chapter 453 or advanced
15		practice registered nurse licensed under chapter 457
16		in the jurisdiction in which the licensee was treated;
17		<u>or</u>
18	(2)	Military service under extended active duty with the
19		armed forces of the United States.

1	(d) Each licensee shall maintain copies of the licensee's
2	continuing competency records for the past four years or two
3	previous bienniums.
4	(e) Upon application for license renewal, restoration, or
5	reinstatement, each licensee shall have complied with and attest
6	to completion of one of the learning activity options recognized
7	by the board pursuant to subsection (a) during the two years
8	preceding the application for license renewal, restoration, or
9	reinstatement and shall be prepared to submit evidence of
10	completion if requested by the board.
11	(f) The board may conduct an audit to determine compliance
12	with the continuing competency requirement. The board shall
13	provide written notice of an audit to all licensees selected for
14	audit. Within sixty days of notification, the licensee shall
15	provide the board with documentation verifying compliance with
16	continuing competency requirements.
17	§457- Learning activity options. (a) The successful
18	completion of one of the following shall meet the learning
19	activity options requirements for continuing competency:
20	(1) National certification or recertification related to
21	the nurse's practice role;

1	(2)	infrey contact hours of continuing education
2		activities;
3	(3)	Completion of a board approved refresher course;
4	(4)	Completion of a minimum of two semester credits of
5		post-licensure academic education related to nursing
6		practice from an accredited nursing program;
7	(5)	Participation as a preceptor, for at least one nursing
8		student or employee transitioning into new clinical
9		practice areas for at least one hundred twenty hours,
10		in a one-to-one relationship as part of an organized
11		preceptorship program; provided that the licensee may
12		precept more than one student or employee during the
13		one hundred twenty hours and shall be evidenced by
14		documentation of hours completed and objectives of the
15		preceptorship by the institution supervising the
16		student;
17	(6)	Completion as principal or co-principal investigator
18		of a nursing research project that is an institution
19		review board project or evidence-based practice
20		project that has been preapproved by the board;

1	<u>(7)</u>	Authoring or coauthoring a peer reviewed published
2		nursing or health-related article, book, or book
3		chapter;
4	(8)	Developing and conducting a nursing education
5		presentation or presentations totaling a minimum of
6		five contact hours of actual organized instruction
7		that qualifies as continuing education;
8	(9)	Completion of a board-recognized nurse residency
9		program; or
10	(10)	A similar type of learning activity option; provided
11		that the type of activity shall be recognized by the
12		board."
13	SECT	ION 3. Section 457-2, Hawaii Revised Statutes, is
14	amended b	y adding three new definitions to be appropriately
15	inserted	and to read as follows:
16	" <u>"Co</u>	mpetency" means the ability of a nurse to integrate
17	knowledge	, skills, judgment and personal attributes to practice
18	safely an	d ethically in the professional nursing position and in
19	accordanc	e with the scope of nationally recognized nursing
20	practices	<u>•</u>

1 "Contact hour" means the same as section 16-89-2, Hawaii 2 Administrative Rules. 3 "Continuing competency" means the long-term educational and 4 professional process by which an individual undertakes and 5 documents with verifiable evidence a personal learning plan that 6 encompasses a periodic self-assessment of personal strengths and 7 weaknesses as present in the individual's practice as a nurse as 8 well as a commitment to furthering the individual's professional 9 knowledge relating to the nursing field." 10 SECTION 4. Section 457-12, Hawaii Revised Statutes, is 11 amended by amending subsection (a) to read as follows: 12 "(a) In addition to any other actions authorized by law, 13 the board shall have the power to deny, revoke, limit, or suspend any license to practice nursing as a registered nurse or 14 15 as a licensed practical nurse applied for or issued by the board 16 in accordance with this chapter, and to fine or to otherwise 17 discipline a licensee for any cause authorized by law, including 18 but not limited to the following: 19 (1) Fraud or deceit in procuring or attempting to procure 20 a license to practice nursing as a registered nurse or 21 as a licensed practical nurse;

2	(3)	Unfitness or incompetence by reason of negligence,
3		habits, or other causes;
4	(4)	Habitual intemperance, addiction to, or dependency on
5		alcohol or other habit-forming substances;
6	(5)	Mental incompetence;
7	(6)	Unprofessional conduct as defined by the board in
8		accordance with its own rules;
9	(7)	Wilful or repeated violation of any of the provisions
10		of this chapter or any rule adopted by the board;
11	(8)	Revocation, suspension, limitation, or other
12		disciplinary action by another state of a nursing
13		license for reasons as provided in this section;
14	(9)	Conviction, whether by nolo contendere or otherwise,

1		within thirty days after the disciplinary action
2		becomes final;
3	(11)	Submitting to or filing with the board any notice,
4		statement, or other document required under this
5		chapter, which is false or untrue or contains any
6		material misstatement of fact[+], including a false
7		attestation of compliance with continuing competency
8		requirements; or
9	(12)	Violation of the conditions or limitations upon which
10		any license is issued."
11	SECT	ION 5. Statutory material to be repealed is bracketed
12	and stric	ken. New statutory material is underscored.
13	SECT	ION 6. This Act shall take effect upon its approval.
