## A BILL FOR AN ACT

---

RELATING TO ALOHA TOWER DEVELOPMENT CORPORATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1       SECTION 1. Section 206J-4, Hawaii Revised Statutes, is  
2 amended by amending subsection (b) to read as follows:

3       "(b) The development corporation shall consist of a board  
4 of directors having [~~three~~] six voting members: The director of  
5 business, economic development and tourism[, ~~the director of~~  
6 ~~transportation, and~~] or the director's designee, the chairperson  
7 of the board of land and natural resources or the chairperson's  
8 designee, the deputy director of transportation, harbors  
9 division, one member representing the maritime industry to be  
10 appointed by the governor as provided in section 26-34, one  
11 member to be appointed by the speaker of the house, and one  
12 member to be appointed by the president of the senate. The  
13 board, by a majority vote, shall elect a chairperson from within  
14 its membership."

15       SECTION 2. Section 206J-4, Hawaii Revised Statutes, is  
16 amended by amending subsection (d) to read as follows:

H.B. NO. 971

"(d) The board [~~shall~~] may appoint a chief executive officer. [The] If a chief executive officer is appointed, the board shall set the salary of the executive officer, who shall serve at the pleasure of the board and shall be exempt from chapter 76."

SECTION 3. Statutory material to be repealed is bracketed and stricken. New statutory material is underscored.

SECTION 6. This Act, upon its approval, shall take effect on July 1, 2015.
