HB 364 Status	RELATING TO NUISANCE ABATEMENT. Adds a building, premise, and place in which a gambling offense is committed as a nuisance that is subject to abatement.	JUD, FIN
HB 413 Status	RELATING TO THE JUDICIARY. Amends the number of judges in the fifth circuit from two to three.	JUD, FIN
HB 739 Status	RELATING TO SERVICE BY PUBLICATION. Clarifies the requirements for service by publication.	JUD, FIN
HB 786 Status	RELATING TO GOVERNMENT RECORDS. Requires agencies to exercise reasonable care in the maintenance of all government records under its control that are required to be made available for public inspection.	JUD, FIN
HB 789 Status	RELATING TO INCOME TAX CREDITS FOR VOTING IN ELECTIONS. Establishes an income tax credit for voting in elections.	JUD, FIN
