SB1377 Status and Testimony RELATING TO THE WAIKIKI-DIAMOND HEAD SHORELINE FISHERIES MANAGEMENT AREA.

Prohibits spearfishing at all hours of the day within the Waikiki-Diamond Head shoreline fisheries management area until such time as the department of land and natural resources determines through research that the damage existing as of January 1, 2016, to the coral reefs has abated and the reefs are restored. Effective 1/1/2016. WTL, WAM [Measure added on 2/13/2015]
