

My name is Wilfredo Tungol and I am currently the HIPAA (Health Insurance Portability and Affordability Act) Office Security Officer. 

Insurance Portability and Accountability Act (HIPAA) Privacy Officer. I am submitting testimony in my
individual capacity in support of Mr. Keith Yamamoto's confirmation as the Deputy Director of Health
for the State of Hawaii. I have had the opportunity of working with Mr. Yamamoto during his tenure as
the Chief of the DOH Alcohol and Drug Abuse Division, and also in his capacity as the current Deputy
Director of Health.

The DOH is a hybrid entity as defined by HIPAA, which means that certain divisions and programs within the DOH are subject to federal HIPAA laws. - 1 Aloha Chair Green and members of the Committee on Health. Thank you for this opportunity to testify
- 2 regarding my desire to serve the state of Hawaii as Director of Health. I welcome this opportunity
- 3 because of my respect and admiration for Governor David Ige and the team he is putting together. I
- 4 believe we have a unique opportunity to work collaboratively with the state legislature to improve the
- 5 economic and public health of the state.
- 6 I am not new to state government, having served as deputy director for the State Department of Health,
- 7 Health Resources Administration (HRA) from January, 1999-2002. During that time I quickly learned to
- 8 love the dedicated and resilient individuals in the department and to fully appreciate the important role
- 9 of public health in its many facets. The beautiful people of Kalaupapa, the developmentally disabled,
- the children with special health needs, the broad diversity of cultures and ethnicities, each with unique
- 11 public health needs, are indelibly imprinted in my mind. The importance of prevention in protecting the
- oral, mental and physical health of our population is undeniable. The role of disease surveillance and
- control allows early intervention to prevent epidemics. Vector control, food inspection, clean water,
- 14 solid waste management, and protection of our precious environment are essential. Behavioral health
- is only recently being fully recognized as a major determinant of morbidity and mortality not only in
- terms of personal well-being but in terms of societal issues with substance abuse, homelessness and
- 17 public safety. During my tenure as HRA deputy director I was fortunate to successfully initiate the
- 18 Tobacco Trust Fund, the Healthy Hawaii Initiative, the Hawaii Outcomes Institute, the Hawaii Uninsured

- 1 Project and successfully closed the State Developmental Disabilities Institution and implemented
- 2 community based self-determination.
- 3 As social determinants of health have become more recognized the intersection among health,
- 4 education and social services make collaboration across departments and between public and private
- 5 sectors increasingly critical. Community health needs assessment and community planning opens new
- 6 possibilities for redefining the role of public health and medical care and the overlap with social services.
- 7 My background and training provide me with the experience and expertise to effectively serve in the
- 8 role of Director of Health. My family has been in Hawaii since 1914. My mother was born on the Big
- 9 Island. My father who was from St. Louis was stationed in Hawaii during World War II. He and my
- 10 mother were married during the war in St. Louis where my four siblings and I were born. Thankfully we
- 11 moved back to Maui where I was fortunate enough to attend Kaunoa School, Baldwin High School and
- 12 Seabury Hall. I learned to love and appreciate the neighbor islands before braving the cold weather in
- 13 Ithaca New York where I attended college at Cornell University.
- 14 Although I enjoyed Cornell I could not wait to return to my beloved Hawaii where I started my career as
- 15 a management trainee at Bank of Hawaii and obtained my MBA at the University of Hawaii. Looking for
- 16 a more meaningful, mission driven career I switched to medicine and graduated from the John A. Burns
- 17 School of Medicine (JABSOM) followed by residency in the University of Hawaii Integrated Surgical
- 18 Residency Training Program. During a 14-month research fellowship at Brigham and Women's Hospital
- in Boston, I met my husband and persuaded him to return to beautiful Hawaii with me. I worked in a
- 20 private practice in general surgery at the Queen's Medical Center and was an associate professor of
- surgery at JABSOM as well as Director of Surgical Education at The Queen's Medical Center. I became
- 22 specialized in breast cancer and realized the dysfunction and fragmentation of our U.S. medical (non)-
- 23 system.
- 24 Given the opportunity in the early nineties to "reengineer" health care I left my private practice to "fix"
- 25 health care. I started as a Vice President, assistant to the President, of The Queen's Health System and
- 26 became President and CEO of the Queen's/ HMSA Premier Plan (a newly formed HMO). I was on a
- 27 mission to change the way health care was delivered but we did not yet have electronic medical records,

- 1 quality metrics, or a means to change reimbursement methodologies. I think we were a bit ahead of the
- 2 curve.
- 3 Public health was next as I accepted an appointment as HRA deputy director as described above. In
- 4 2002 with the merger of Wilcox, Straub, Pali Momi and Kapiolani Medical Center for Women and
- 5 Children to form Hawaii Pacific Health (HPH) I realized a new opportunity to make a difference in the
- 6 private sector. I am extremely proud of our accomplishments at Hawaii Pacific Health over the past 13
- 7 years. I finally believe that our health care system is headed in the right direction. I felt comfortable
- 8 leaving HPH at this time, knowing that HPH has excellent leadership and will continue on path to
- 9 improve health care for all.
- 10 So now, if my nomination as Director of Health is approved, I look forward to eight years working with
- 11 Governor Ige and the new administration and the legislature to help work collaboratively across
- 12 departments to address the intersection of public health and medical care and social services and
- education and environment. I specifically wish to see a statewide interdepartmental/interdisciplinary
- mental health strategic plan that addresses integration of behavioral health into primary care,
- 15 preventative care, transitional care for substance abuse disorder, comprehensive wrap around care for
- super users, and access to care for all including Quest members and uninsured. I wish to see the Hawaii
- 17 State Hospital in Kaneohe implement its master facility plan. I am committed to successful
- 18 implementation of medical marijuana dispensaries. I am committed to completing successful
- 19 negotiation with the Navy on Red Hill. I am also committed to the \$3 million maintenance of effort for
- the home visitation program for which we just received \$9 million in Federal Funds to make sure every
- 21 child has a healthy start. Finally I will support our continued efforts to make our department paperless.
- 22 I wish to acknowledge Keith Yamamoto who is my partner at DOH. He and I make an excellent pair as I
- love the big picture and he loves the detail. We work exceedingly well together. I also wish to recognize
- 24 the other deputies and staff at DOH. Together, we make a highly effective and dedicated team. Thank
- you for this opportunity to serve the state and people I love so much.


