TESTIMONY OF LOWELL CHUN-HOON RE: GM 536, THE APPOINTMENT OF LEONARD HOSHIJO AS DEPUTY DIRECTOR, DEPARTMENT OF LABOR AND INDUSTRIAL RELATIONS

Chairman Keith-Agaran, Vice Chair Shimabukuro, and Members of the Committee:

Thank you for the opportunity to present testimony regarding the appointment of Leonard Hoshijo to serve as Deputy Director of the Department of Labor and Industrial Relations. I completely support this excellent appointment.

I am a practicing labor lawyer with thirty-seven years of experience appearing before the State Department of Labor and Industrial Relations representing individuals and labor unions in workers compensation, unemployment, prohibited practice, and temporary disability insurance claims. I have also personally worked with Mr. Hoshijo when he served as the International Vice President of ILWU Local 142 and as a colleague at the A.Q. McElrath Fund for Economic and Social Justice.

Mr. Hoshijo is one of the ablest and most thoughtful union officials I have ever had the privilege of working with. He is highly intelligent, responsible, and considerate in his relations with his colleagues. Among the attributes he will bring to his work is a broad vision of social responsibility and a sophisticated, nuanced approach to problem solving. His personal discipline, objectivity, perseverance, and broad knowledge of labor relations will also make him an impartial and efficient government administrator.

Mr. Hoshijo, for example, has done outstanding work creating affordable housing for low income tenants at the 143 unit Jack Hall Memorial Housing project in Waipahu. He also was very active with the late Justice Edward Nakamura in preserving and restoring the renowned mural created by Pablo O'Higgins at the ILWU Local 142 headquarters at 451 Atkinson Drive. His supportive background work was also instrumental in bringing to fruition Tom Coffman's celebrated biography of Justice Nakamura, *I Respectfully Dissent*. In my own work with the A.Q. McElrath Fund for Economic and Social Justice, Mr. Hoshijo has helped to fund projects that promoted

racial diversity, gay rights, internal union education, and organizations that helped make medical care accessible to victims of human trafficking victims through grants issued by the Fund.

I mention this array of activities to underscore that Mr. Hoshijo's work continues the best of organized labor's historical tradition as a visionary and transformative social force that is concerned with more than the accumulation of wages, pensions, and ancillary benefits in union contracts. As important as these basic daily issues are, Mr. Hoshijo has consistently sought more wide ranging reforms of enduring value that benefit our entire community. Thus, he has promoted the value of art in celebrating the struggle to achieve equality and justice for workers of all nationalities, and has used his position as a union official to address the urgent need for housing in our state. If confirmed, I believe he will help conceive and espouse similar programs and, even in a time of fiscal restraint and austerity, will find imaginative ways in which government may fulfill its mission to train and uplift the workforce and promote a vigorous economy.

While I cannot speak for the business community, it is my belief that community-minded entrepreneurs and business owners will also welcome his appointment because of Mr. Hoshijo's deserved reputation for integrity, constructive engagement, and fair dealing.

I therefore urge that Mr. Hoshijo swiftly be confirmed. Thank you very much for considering my remarks.
