- 5 is familiar with detailed reports and spreadsheets related to corporate objectives and client
- 6 specific requests ensuring confidentiality of sensitive information. Her ten years of proven
- 7 administrative skills as a project manager has enabled her to manage complex tasks and to
- 8 adhere to specific timelines. Ms. Lyons' knowledge and experiences in the corporate business
