TESTIMONY ON GOVERNOR'S MESSAGE NO 732.

TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Sandra Matsushima and I am the Executive Officer for the Board of Examiners in Optometry, Department of Commerce and Consumer Affairs ("Department"). The Department thanks you for the opportunity to testify on Governor's Message No. 732, regarding the **reappointment** of Gayle C. Chang to the Board of Examiners in Optometry ("Board"). The Department supports the confirmation of Ms. Chang's reappointment to the Board.

Ms. Chang is a reliable member and has attended 25 of 29 meetings. She has been serving on the Board since July 1, 2010. Ms. Chang has been a conscientious Board member who comes well prepared to discuss the matters on the Board's agendas, and whose willingness to learn the issues surrounding the practice of

The Department supports the confirmation of Gayle C. Chang's reappointment to the Board of Examiners in Optometry, and thanks you for the opportunity to provide testimony.
