Honorable Chair Chun Oakland and Members of the Senate Committee on Human Services and Housing, thank you for the opportunity to provide you with comments regarding Governor's Message 796 (G.M. 796), submitting for consideration and confirmation to the Board of Directors of the Hawai'i Public Housing Authority, Gubernatorial Nominee, Mr. Jason Espero, for a term to expire June 30, 2019.

The Hawaii Public Housing Authority (HPHA) <u>supports</u> the confirmation of Mr. Espero to the HPHA Board of Directors for a second four year term. Over the past four years, Mr. Espero has served as an invaluable member and Vice-Chair to the HPHA Board of Directors, and has consistently advocated on behalf of people with disabilities, homeless individuals and families.
