Purpose of Bill: Requires state departments, upon the closure of facilities, to consider

the facility's suitability for use by public charter schools or early learning

pre-plus programs, and to notify the State Public Charter School

Commission or Executive Office on Early Learning of the availability and suitability of the facility. Requires more detailed annual reporting by the State Public Charter School Commission. Establishes a Charter School Facilities Funding Working Group. Appropriates funds for public charter schools. Authorizes the issuance of general obligation bonds and appropriates funds for public charter school facilities' design, planning,

construction, repair, and maintenance. (HB1251 HD1)

Department's Position:

The Department of Education (DOE) would like to provide comments of concern related to HD1251 HD1. The intent of the measure is to provide a process to more readily identify needed facility space for charter and preschools. However, we are concerned that the process places DOE in a role of managing facilities that are not under its control or management. The measure appears to propose to bypass the oversight and management of state buildings that are more appropriately overseen by the Department of Accounting and General Services.

As such, the Department of Education cannot support this measure.

Comments: Financial support for Hawai'i charter school facilities is the missing piece in terms of supporting charter school success. There is significant research showing that adequate educational facilities contributes to student success. Without facilities funding support, charter schools are required to dedicate funds to facilities, which funds would otherwise be allocated to supporting the schools' educational programs. In addition, lack of facility funding for charters presents an equity issue for charter school teachers, who are held to the same standards in terms of their students' performance, but who have significantly less resources with which to work. Though stated the DOE would provide information on the curricula to the public, it does not say all "mediums" within the curricula will be made available to the public. Parents should prepare statements to how they want to be informed regarding sex education, and what concerns they have about how students are treated if they are not a part of the program, insuring their grades/scores will not be affected nor will the student feel shamed or embarrassed for not participating in the sex-ed curriculum.
