I am Doug Mayne and I am the Administrator of the Hawaii Emergency Management Agency. I am testifying in **SUPPORT** of HB 1343 HD1.

House Bill 1343 HD1 appropriates bond funding to match a federal grant of \$1,159,000 to enable Hawai'i to develop a Business Recovery Center (BRC). The purpose of the Business Recovery Center is to become a location (physical and virtual) for the private sector and government to share information and to collaborate before, during and after disasters.

Activities that will occur in the BRC include: establishing information channels to allow the private sector to access information including the status of utilities and roads; allowing the private sector to post information about operating hours during and after disasters; and a location to post requests for proposals so local businesses can bid on contracts let during and after disasters.

The focus of the BRC is to develop procedures to speed information flow and collaboration to ensure the economy of Hawai'i recovers as quickly as possible after a disaster.

I am Brigadier General Arthur J. Logan, State Adjutant General and the Director of the Hawaii Emergency Management Agency. I am testifying in **SUPPORT** of House Bill 1343 HD1.

This measure appropriates \$328,000.00 for the establishment of a business recovery center within the Department of Defense. This appropriation is necessary for the State of Hawaii to receive the Federal match of \$1,159,000.00 to support this initiative.

A business recovery center is an online website where business and government agencies collaborate before, during and after a disaster. Federal disaster program information is distributed through this portal.

After a major disaster, the longer a business remains closed dramatically increases the risk of that business failing. The Federal Emergency Management Agency (FEMA) has found that about 40% of small businesses fail after a catastrophic event.

The business recovery center will be an important part of Hawaii's recovery after a major disaster. Please support this important resiliency initiative.
