Chair Espero, Vice Chair Baker, and Members of the Committee:

The Department of Public Safety (PSD) supports the intent of Senate Concurrent Resolution (SCR) 149, requesting the Auditor conduct a financial audit of commissary operations at out-of-state correctional facilities contracted to house Hawaii inmates.

Pursuant to the PSD's contractual agreement with Corrections Corporation of America (CCA), proceeds from the commissary services shall benefit inmates housed at Saguaro Correctional Center. Proceeds shall be used for items such as recreation equipment, satellite television in housing units, and food prizes for the entire housing unit awarded in monthly dorm competitions for the cleanest unit. Revenues are used for commissary operating expenses such as inventory purchase and commissary worker salary and benefits.

All correctional facilities in Pinal County are required to charge Arizona state tax on taxable commissary items. Saguaro Correctional Center is the only facility that adds

an additional 4% surcharge to taxable commissary items in accordance with §353-136, Hawaii Revised Statutes. Phone time and postage stamps are exempt from the state tax and surcharge.

The PSD will assist the Auditor's Office in collecting the information necessary to conduct the audit and facilitate access to correctional facilities upon request.
