RE: SCR165/SR101 SUPPORTING THE CO-NAMING OF A SECTION OF 33RD STREET IN NEW YORK CITY TO FATHER DAMIEN WAY IN HONOR OF SAINT DAMIEN DE VEUSTER.

Chair Dela Cruz, Vice Chair Nishihara, and Members of the Committee:

My name is Patti Danko and I am writing in strong support of SCR165/SR101. I live in New York City and am on the Board of Hālāwai. We are committed to building and supporting a community of people who share a common background or interest in Hawai'i. In the tradition of extended 'ohana (family), Hālāwai perpetuates the aloha spirit by bringing people together and providing a gathering place.

Flanders House contacted Hālāwai in March of 2014 and asked for support in the street co-naming project. Father Damien Way, located on 33rd Street between 1st and 2nd Avenues, is in the immediate proximity of three important hospitals, including the Mid-Atlantic Regional Hansen's Disease Center at Bellevue Hospital, which provides testing and treatment of Hansen's disease.

Flanders House was formed and is funded by the Government of Flanders, a regional government of the federal country, which is Belgium. Flanders House promotes a better understanding of the region of Flanders through the arts, science, technology and education. Flanders was instrumental in the establishment of "New Amsterdam" 400 years ago and has built a strong historical and cultural link with the US.

Father Damien was born as Joseph De Veuster in Tremelo in Flanders, Belgium in 1840. He entered the Congregation of the Sacred hearts of Jesus and Mary in Leuven, took the name of Damien and left for Hawai'i as a missionary in 1864. He arrived in Kalaupapa on May 10, 1873 and ministered to the people of the Hawaiian Kingdom who were exiled there because they had leprosy, now known as Hansen's disease. He contracted leprosy and died in 1889. His legacy of faith, compassion and dedication for the most vulnerable among us is an inspiration to us all. He was a priest and healer, a community leader, early human rights activist, and a catalyst for the current movement to eradicate neglected infectious diseases.
