Why include senior centers?

For example, at Catholic Charities Hawai`i's Lanakila Multi-Purpose Senior Center:

- Education offerings include topics such as Excel & iPad for Seniors and Leadership Training
- The senior center partners with other organizations to recruit seniors and provide space for offerings such as AARP's Defensive Driving and DOE Adult Education's Basic English
- Education activities are provided for over 350 older adults each year

On Oahu, the four senior centers that are not affiliated with C&C Parks & Recreation facilities are:

- 1. Lanakila Multi-Purpose Senior Center
- 2. Moiliili Multipurpose Senior Center
- 3. Kapahulu Center
- 4. Waikiki Community Center
