

# SCR191 SD1/SR126 SD1 ENCOURAGING THE DEPARTMENT OF EDUCATION TO ESTABLISH A VOLUNTARY FARM TO SCHOOL PROGRAM

The Office of Hawaiian Affairs (OHA) Committee on Beneficiary Advocacy and Empowerment will recommend to the Board of Trustees a position of **COMMENT** for SCR191 SD1/SR126 SD1, which encourages the Department of Education to establish a voluntary farm-to-school program.

Farm-to-school programs take an integrated approach to simultaneously improve the health of students and their families, while also supporting the local food industry. The voluntary farm-to-school program promoted by this measure would give Department of Education Complex Areas the option to purchase locally grown food from food safety certified farms. The program also includes nutrition education and educational activities that emphasize food and farming. Such a voluntary farm-to-school program may be an important initial step towards achieving better health outcomes and greater food self-sufficiency in our islands.

In addition to supporting healthy choices and healthy children, this measure will support the state's food self-sufficiency goals, by increasing support for Hawai'i's local agricultural economy. In adopting the targets of the Aloha+ Challenge, the state has committed to doubling local food production by 2030. OHA notes that the principles underlying the Aloha+ Challenge support a renewed commitment to the sustainability practiced by our ancestors, and perpetuated today through the traditional concept of malama 'āina. By sourcing school meals to local farms, this bill invests in local food production, which may in turn lead to more agricultural jobs, greater incentives for farmer training, and the preservation of agricultural land for agriculture.

The Hawaii State Teachers Association (HSTA) <u>supports SCR 191/ SR 126</u> relating to encouraging the Department of Education to establish a voluntary farm to school program.

We are an island state with a long history of connection to the land that predates western contact. Throughout Hawai'i's history, the land and that which that land produces has been essential in the sustainability of our people and our economy.

In recent history, our "disconnect" with the land and our almost sole reliance on food from other shores has put our citizens in a precarious state. While we are all closely monitoring the labor dispute related to shipping to Hawai'i and its potential impact on our food supplies, we are also aware of the growing number of food recalls that are also occurring.


