Chair Wakai, Vice Chair Slom, and Committee Members:

I am Keone Kali, State Chief Information Officer (CIO), providing comments supporting the intent of S.C.R. No.162. First, we appreciate the strong support this Legislature has provided for the State's technology initiatives during the short time I have been the State CIO. Second, with the funds you appropriated, we have made great strides in the past year to resolve critical issues like State network uptime and cyber security. Investments in the State's upgraded Content Delivery Network, Security Operations Center, and Hawaii Government Private Cloud (GPC) over the past year alone have built solid foundations across departments that will help us to collaborate, consolidate, and transform the way government does business. With those new platforms, the State inaugurated in January its updated Human Resources Management System (HRMS), a previously "at risk" system that had been waiting a decade for a cost-effective, robust, and reliable solution.

Based on direction from the new administration, OIMT is working closely with State Comptroller Douglas G. Murdock to focus on priority projects that will stabilize and improve the efficiency of government operations and services in the near-term and employ a business-like approach to prioritize projects that will deliver efficiencies and cost-savings within the next two years and within current funding levels and organizational structures.

To accomplish our refocused, targeted objectives, we request the committee support this resolution that will document statewide IT spending that we estimate is approximately \$150 million annually. While we currently monitor some IT spending, a comprehensive financial audit of State Executive Branch information technology expenditures will greatly help us to execute the level of enterprise technology budget planning that will improve the coordination and integration of overall business process and technology spending.

Further, compiling an accurate and up-to-date IT Investment Portfolio for the Executive Branch will provide a complete picture of technology investments, which is necessary to make strategic decisions to meet our target of reducing recurring IT costs in future years.

Thank you, again, for your ongoing support and for the opportunity to testify on this matter.
