- Identification of any agreement between the State-Lange Group by which Lange Group also receives fees from individual subscribers accessing the Bureau of Conveyances' digitized database of conveyance filings.

Please produce any agreements between 2003-present authorizing Lange Group's use of Bureau of Conveyances' images and/or indexing features for purposes outside the scope of Lange Group contract 46621.
