SUBJECT: Monthly LCATS Billing and Deposits

Effective July 1, 1995 all monthly billings for LCATS will be assumed by the Bureau. Since Hawaii, Inc. was abolished, their private billing company, Profitability of Hawaii (POH), will no longer be handling the account.

There are currently 13 users that are billed \$150 monthly plus a per minute charge. Two others--Title Guaranty's second log-on and Imperial Hawaii--are charged \$100 per month plus per minute charges. The attached POH records for May 1995 can be used to find a list of all the current users. Please bill the same users for June 1995. Until ICSD is able to provide us with each user's time and charges, we have waived the per minute charges for June 1995.

Also attached are payments we have received to date from POH for their May 1995 billings. Please deposit all LCATS payments to a new source code: 792.
