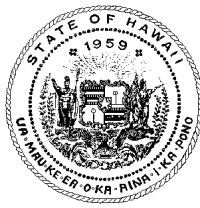

Chair Ige, Vice Chair Kidani, and Members of the Committee:

The Department of Public Safety is in **support** of HB 154, HD 2, SD 1 **with amendments**. We understand that hemp has for a long time been classified as a controlled substance by the federal government and our state, as it is a member of the cannabis family. However, the federal position on hemp, at least on industrial hemp, has shifted. This is reflected in the recently enacted Agricultural Act of 2014, or Public Law 113-79. Section 7606 of that law exempts the growing and cultivation of industrial hemp from the Controlled Substance Act under certain conditions. This bill would authorize the growing and cultivation of this product under conditions which meet the Agricultural Act of 2014. However, this bill would require that the University obtain a registration from the Drug Enforcement Administration. In view of the fact that the Agricultural Act of 2014 would specifically exempt this project from

the Controlled Substance Act, we recommend that the requirement for DEA registration be deleted from the bill.

Chairperson Ige and Members of the Committee:

Thank you for the opportunity to testify on House Bill No. 154, Senate Draft 1. This bill authorizes the College of Tropical Agriculture and Human Resources at the University of Hawaii to establish a two-year industrial hemp remediation and biofuel crop research program under specified conditions and with an appropriation. The Hawaii Department of Agriculture (HDOA) supports the intent of this measure; however, we note Senate Draft 1 predates the enactment of Section 7606 of the United States Agricultural Act of 2014 which authorizes institutions of higher education and state departments of agriculture to conduct industrial hemp research.

Senate Draft 2 (Proposed) includes reference to the aforementioned Section 7606. The Department of Agriculture supports SD2, but we defer to the University of Hawaii's College of Tropical Agriculture and Human Resources in regards to the implementation of such a pilot project.

HB 154 HD2 SD1 – RELATING TO INDUSTRIAL HEMP

Chair Ige, Vice Chair Kidani, and members of the Senate Committee on Ways and Means, thank you for this opportunity to offer comments in support of HB 154 HD2 SD1, which would authorize the director of the College of Tropical Agriculture and Human Resources (CTAHR) at the University of Hawai'i at Mānoa to establish a two-year industrial hemp remediation and biofuel research program, subject to obtaining federal and state permits.

HB 154 HD2 SD1 is one of three bills currently under consideration for the same purpose.

We support the intent of HB 154 HD2 SD1, but note that the bill is out of date with respect to legal requirements, since it was introduced in the 2013 regular legislative session. It is our understanding that any permit requirements have been superseded by Section 7606 of the Agricultural Act of 2014, also known as Public Law 113-79.

Our sole concerns with all three similar bills are (1) that adequate funding be provided for any research to be conducted, (2) that such research and funding not replace nor adversely impact any priorities as indicated in the University's Board of Regents' Approved Executive Biennium Budget, (3) and that a minimum two-year period be allowed in order to obtain meaningful research results. We have determined that the costs of a two-year research program are \$150,000.

Aloha Chair Ige, Vice Chair Kidani, and Members of the Committee

Life of the Land is Hawai`i's own energy, environmental and community action group advocating for the people and `aina for four decades. Our mission is to preserve and protect the life of the land through sound energy and land use policies and to promote open government through research, education, advocacy and, when necessary, litigation.

Harry Jacob Anslinger was appointed as the first commissioner of the U.S. Treasury Department's Federal Bureau of Narcotics (FBN). He served for 32 years (1930-62).

Anslinger intentionally alarmed the public as part of a broad effort to outlaw all recreational drugs. In 1934 he launched an anti-marijuana campaign.

As a result of the anti-marijuana campaign, there was a sharp drop in the U.S. production of industrial hemp.

Car manufacturers are increasingly using natural fibers (hemp, coconut, bamboo and kenaf) in car interiors to make cars feel more comfortable and less like plastic.

During WW2 the military released films encouraging farmers to grow industrial hemp. One film was called "Hemp for Victory." It can be viewed at https://archive.org/details/Hemp_for_victory_1942.

HB154 HD2 SD1 authorizes the director of the college of tropical agriculture and human resources at the University of Hawaii at Manoa to establish a two-year industrial hemp remediation and biofuel crop pilot program.

This is but the latest attempt to note that hemp is a valuable product.

On October 17, 2000 U.S. Senator Daniel Inouye wrote a letter to Cynthia Thielen

“I would like to share with you a copy of a letter I received from the Drug Enforcement Administration in response to my letter on your behalf.

The Hawaii Industrial Hemp Research Project permit to import cannabis seed has been issued. I am confident the project will continue to provide important information on which to determine the future of the hemp industry in Hawaii.”

In 1999 Life of the Land’s Kat Brady testified in favor of an industrial hemp bill (HB 32 HD1)

Life of the Land supports HB 32 HD 1 which would authorize the state to allow privately funded industrial hemp research to be conducted in Hawai`i. Hemp is one plant that is resistant to one of our biggest agricultural pests - nematodes. Hemp is also a very versatile plant which could really spur some positive economic growth for Hawai`i’s businesses.

Several years ago a company which created fiberboard from hemp for building supplies was being touted on the stock exchange as a real growth stock. The building supplies they were manufacturing were strong and had longer lives than the traditional sheetrock used in construction. The article I read stated that hemp fibers were longer and much stronger and therefore made a more durable product.

Hemp is a very versatile product and it seems that Hawai`i’s weather would be perfect to grow this hearty plant to create a new growth industry for us. Hemp could be thing boost our economy needs at this time.

In 2002 Life of the Land’s Kat Brady testified in favor of another industrial hemp bill (HB 57)

Life of the Land supports this measure. Hemp is one crop resistant to nematodes -- a huge problem in Hawai`i. Hemp is a versatile crop which can be used for food, building materials because of its long fibers, paper, and clothing, to name a few. We support keeping our agricultural land in agriculture and with the closing of our sugar industry, hemp is a great alternative requiring less pesticides.
