HEALTH, AND THE CITY AND COUNTY OF HONOLULU TO TAKE NECESSARY
STEPS TO EXPEDITE CONSTRUCTION FOR THE EXPANSION AND IMPROVEMENT
OF THE REPLACEMENT WASH-DOWN STATIONS AT MAUNALUA BAY.**

House Concurrent Resolution 202/House Resolution 138 urges the Department of Land and Natural Resources (Department) to expedite the expansion and improvement of the wash-down facilities located at Maunalua Bay, Oahu. **The Department offers the following comments.**

New wash-downs were constructed and parking lot improvements were completed in Maunalua Bay on November 18, 2013 at a cost of \$184,000. The existing two wash-down stations were replaced with three new stations and relocated outside of the existing parking area so the runoff of the water would no longer undermine the asphalt causing potholes. Also, the new wash-down area was constructed with concrete and in an area where the runoff would no longer be able to enter the near shore waters and resolve any Department of Health concerns.

Upon completion of the project, a few boaters complained that at times they had to wait to use the wash-down area because of the new configuration. The Department contacted the City and County of Honolulu to inquire whether the County would be willing to provide additional land located along the new wash-down so the facility could be expanded. The City and County of Honolulu agreed and the Department has planned an expansion of the wash-down based on input from the Boaters. The project is estimated to cost approximately \$100,000. The Department feels that the existing facility is adequate and meets the needs of the Boaters but is willing to expand the facility should the Legislature provide the necessary funding to complete the project.
