Dear Committee on Human Services & Housing:

The Pacific Alliance to Stop Slavery (PASS) strongly supports **SB273**. PASS has been helping the houseless population in Kakaako for the past year. We attest that the existing laws that are utilized to “sweep” the sidewalks and parks of homeless persons are extremely harmful to this vulnerable community.

These laws criminalizing the poverty make it exponentially difficult for social services to maintain contact with the houseless to direct them toward permanent housing. These City-run sweeps or “raids” on homeless encampments result in the unconstitutional confiscation and disposal of identification documents such as social security cards, birth certificates, state identification cards, driver’s licenses, and marriage licenses, all of which are documents needed to obtain and maintain benefits, housing, housing first, employment, and medication for serious medical conditions.

Once these documents are disposed of in City raids, it is nearly impossible for the houseless to receive a re-issuance of their identification cards. This measure would help hundreds of houseless obtain their much-needed identification to be able to obtain the benefits and help that they deserve to exit out of poverty.

Please pass **SB273**. Mahalo for your time.

Honorable Chair Chun Oakland and committee members:

I am Kris Coffield, representing the IMU Alliance, a nonpartisan political advocacy organization that currently boasts over 300 local members. On behalf of our members, we offer this testimony in support of SB 273, relating to identification cards.

Over the past three years, Honolulu Mayor Kirk Caldwell and the Honolulu City Council have enacted several ordinances aimed at “compassionately disrupting” homelessness on O’ahu. The most prominent of these ordinances are recently enacted sit-lie bans, which were originally implemented in high commerce areas like Waikiki, but have been expanded to commercial properties located in all regions of O’ahu, including windward and leeward towns and, most recently, malls bordered by businesses. Additionally “obstruction” ordinances target property stored on sidewalks and houseless persons remaining in parks after operating hours. These city ordinances amount to an unconstitutional criminalization of the homeless. Councilmembers have stated that the new laws do not specifically target the homeless, but rather anyone engaging in obstructive activity.

Many judges and legal experts around the country have repeatedly argued that these laws are selectively enforced against the homeless in the form of unannounced property raids, which constitute an unconstitutional violation of the Fourth Amendment's search and seizure protections. For clarity, the Fourteenth Amendment provides that:

“The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.”

Again for clarity, the terms “search” and “seizure” were concisely summarized in the majority opinion to *United States v. Jacobsen*, 466 U.S. 109 (1984), which declared that Fourth Amendment, “protects two types of expectations, one involving 'searches', the other 'seizures'. A

search occurs when an expectation of privacy that society is prepared to consider reasonable is infringed. A *seizure* of property occurs where there is some meaningful interference with an individual's possessory interests in that property.” According to these understandings, When law enforcement, without notice, raid a homeless encampment and usurp—and often destroy—homeless people's belongings, including basic government documents and identification, the city is infringing homeless people's civil rights.

During property raids, homeless people's government-issued documents are often confiscated, documents that are necessary for employment applications, housing applications (including entrance into Housing First programs), travel, and identity verification. We encourage you to pressure city officials to stop stealing people's government-issued identification. In light of the continuance of such theft, however, we urge you to pass this bill allowing the examiner of drivers to accept a sworn statement from a victim services organization, attorney, member of the clergy, or medical or health professional as documentary evidence of a homeless person's address, date and place of birth, occupation, or social security number. This will minimize the services and everyday living disruption for homeless people needing to re-obtain confiscated ID cards.

Hawaii Youth Services Network (HYSN), a statewide coalition of youth-serving organizations, supports SB 273 Relating to Identification Cards.


Lack of legal identification is a serious barrier to obtaining employment or services for persons who are homeless. Driver licenses are required for many jobs. Without identification, a person may be unable to enroll in school, obtain public assistance, rent an apartment, or obtain mental or physical health treatment.

When the individual cannot provide proof of address, date and place of birth, occupation, or social security number it is very difficult to obtain a driver license.

Allowing qualified professionals to provide documentation via a sworn statement is a reasonable and appropriate way to remedy the situation. This bill facilitates efforts to help homeless persons leave the streets for safe and appropriate living situations and to become more self-sufficient.

Comments: Aloha Mai, Esteemed Chair Chun-Oakland, Vice-Chair Green, and members of the Senate Committee on Human Services and Housing: As a life-long resident of Hawai'i, I am writing to express my STRONG SUPPORT of SB 273 "Relating to Identification Cards", which "Allows the examiner of drivers to accept a sworn statement from a victim services organization, attorney, member of the clergy, or medical or health professional as documentary evidence of a homeless person's address, date and place of birth, occupation, or social security number." Having worked in social services as early as 1989 through the the early 2000's, I have witnessed the profound effects of houselessness and lack of domicile on individuals, families, and most tragically, youth. One of the most ironic of "Catch-22"'s in being or serving the undomiciled is the fact that once one becomes undomiciled, one can no longer obtain employment, financial assistance, enroll in health insurance and education, or even access basic government assistance, all essential to breaking the cycle of undomiciled status, because the most basic requirement for all of these is a valid form of identification. Worse, our current identification documents require not only evidentiary documentation of domicile, but also of birth date and location (i.e., birth certificate). However, 1) being undomiciled renders the first impossible to fulfill, and 2) if one no longer has a valid identification, either through seizure, loss, damage, or loss of domicile, one cannot obtain a birth certificate. This leads to an irreconcilable inability to provide basic identification necessary for access to all other fundamental, essential services, and therefore, creates an institutionalized barrier to undomiciled individuals and families obtaining safe, affordable housing and the ancillary services necessary to support them. SB 273 offers a reasonable way of providing undomiciled persons access to that most essential of documents, a basic identification card. I respectfully request that the members of the Committee vote in support of SB 273. Me ke aloha pumehana, Ms. Kahana H.
