RELATING TO THE ENVIRONMENT**

Senate Bill 70, Senate Draft 1 proposes to establish 2.0 FTE positions and appropriate funds to continue small boat harbor saturation enforcement operation pilot testing within the Ala Wai and Keehi Small Boat Harbors and develop effective enforcement for the State's small boat harbors. **The Department of Land and Natural Resources (Department) supports this measure, provided that its passage does not replace or adversely impact the priorities identified in the Executive Supplemental Budget request.**

Continuation of consistent and ongoing enforcement in Hawai'i's small boat harbors remains a priority for the Department and its Division of Conservation and Resources Enforcement (DOCARE). The creation of the requested positions will help to expedite and enhance DOCARE's efforts to recruit and fill vacancies as well as increase administrative capacity.
