**Title of Bill:** HB 0515, HD1 RELATING TO THE DEPARTMENT OF EDUCATION.

**Purpose of Bill:** Requires the auditor to audit the department of education's school food services branch to determine how much local produce is being purchased and served to students. Effective 7/1/2050. (HD1)

**Department's Position:**

The Hawaii State Department of Education (Department) supports the intent of HB 515, HD1 to have the State auditor conduct an audit of the School Food Services Branch to determine the amount of local produce being purchased and served to students.

The School Food Services Branch is currently performing its own internal audit to evaluate the amount of local product purchased since the 2019-2020 school year. Evaluating the prior year's procurements will assist the Department with assessing baseline amounts of local produce purchase prior to the COVID-19 pandemic.

Aloha Chair Luke, Vice-Chair Cullen, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

**The Hawaii Farm Bureau supports HB 515, HD1**, which requires the auditor to audit the department of education's school food services branch to determine how much local produce is being purchased and served to students.

HFB strongly supports the increased use of locally grown agricultural products, fruits, vegetables, meats, dairy, and poultry products in our schools.

In previous sessions, when bills were introduced to remove the local agriculture preference and to return to exempting locally-grown agricultural products from the procurement code, HFB has requested clear metrics to help determine the success of the procurement code with the exemption.

Product purchase data help increase the purchase of more locally-grown agricultural products, fruits, vegetables, meats, dairy, and poultry products for our Farm to School program.

Dear Chair Luke and Members of the Committee:

My name is Micah Munekata, and I am the Director of Government Affairs at Ulupono Initiative. We are a Hawai'i-focused impact investment firm that strives to improve quality of life throughout the islands by helping our communities become more resilient and self-sufficient through locally produced food; renewable energy and clean transportation; and better management of freshwater and waste.

**Ulupono supports HB 515 HD 1**, which requires the State Auditor to audit the Department of Education's School Food Services Branch to determine how much local produce is being purchased and served to students.

Ulupono supports increasing local food within the Department of Education's school meal programs. We believe it is in the State's best interest to establish a baseline from which the Department of Education can make administrative decisions to increase locally grown food in our schools. We recommend adding further information to this audit to include detailed metrics similar to the annual report listed in HB 767. This audit should not preclude the Department of Education from moving forward with locally grown food procurement goals and objectives.
