(COVID-19 [Novel Coronavirus])**

**HONOLULU'S COVID-19 RECOVERY FRAMEWORK:
AMENDMENT TO EMERGENCY ORDER NO. 2020-30**

By the authority vested in me as Mayor of the City and County of Honolulu (the “**City**”) pursuant to Revised Charter of the City and County of Honolulu 1973 (2017 Edition), as amended; the Revised Ordinances of the City and County of Honolulu 1990, as amended; the Hawai‘i Revised Statutes, as amended (“**Haw. Rev. Stat.**”); the Constitution and laws of the State of Hawai‘i (the “**State**”); I, KIRK W. CALDWELL, hereby issue this amendment to Emergency Order No. 2020-30 (Honolulu’s COVID-19 Recovery Framework: Amended and Restated Order Implementing Tier 2) issued on November 20, 2020 (“**Order/Amendment**”) to further address the emergency declared in the Ninth Proclamation of Emergency or Disaster (COVID-19 [Novel Coronavirus]) that I issued on November 20, 2020.

Emergency Order No. 2020-30 (Honolulu’s COVID-19 Recovery Framework: Amended and Restated Order Implementing Tier 2) is hereby amended by adding an Order 10, as set forth below:

Order 10: City exemptions from State’s COVID-19 related mandatory self-quarantine for out-of-State travelers.

- A. Exemption through post-arrival second test. This exemption applies to individuals entering the State through the Daniel K. Inouye International Airport (“**DKI Airport**”) who are able to provide confirmation that they have taken a COVID-19 test prior to travel, but who are subject to the State’s COVID-19 related 14-day mandatory self-quarantine for out-of-State travelers because they have either (1) not received their test result, or (2) their test result has not been accepted by the State. Such individuals may voluntarily choose to take a second COVID-19 test — at the City’s expense, unless the test is covered

by the individuals' insurance carrier — from the lab located at the Daniel K. Inouye International Airport operated by the National Kidney Foundation of Hawai'i ("DKI Lab"). Individuals choosing to take this second test, must also install the City's quarantine application to a smart device and use it until they receive a negative test, or their quarantine period otherwise expires. Upon receipt of a negative COVID-19 test result, and acceptance of the result by the State, the individual who took the second test shall be released from the State's mandatory self-quarantine order.

- B.** Exemption for individuals holding limited exemptions from the State. This exemption applies to individuals entering the State through the DKI Airport who have obtained a limited exemption from the State with regards to the State's COVID-19 related 14-day self-quarantine for out-of-State travelers. Such individuals may voluntarily choose to pay for and take a COVID-19 test from DKI Lab. Individuals choosing to take this test, must also install the City's quarantine application to a smart device and use it until they receive a negative test, or their quarantine period otherwise expires. Upon receipt of a negative COVID-19 test result, and acceptance of the result by the State, the individual who took the second test shall be fully released from the State's mandatory self-quarantine order.
- C.** Exemption for individuals who did not take a pre-travel test. This exemption applies to individuals entering the State through the DKI Airport who did not take a pre-travel COVID-19 test under the State of Hawai'i "Safe Travels Program." Such individuals may:
- (1) voluntarily choose to pay for a COVID-19 test from the DKI Lab;
 - (2) install the City's quarantine application to a smart device and use it for the duration of any quarantine imposed; and
 - (3) if the first test from the DKI Lab is negative, remain in self-quarantine and take a second COVID-19 test on the fourth day after arrival administered again by the lab located at DKI Airport and at the person's own expense.

Upon receipt of both the first and second negative COVID-19 test results required under this section, and acceptance of those negative results by the State, the individual shall be released from the State's 14-day mandatory self-quarantine order.

- D.** Any person whose COVID-19 test result from the DKI Lab is positive under this Order 10 shall be subject to immediate isolation at their planned lodging accommodation (e.g., hotel, legal vacation rental, or residence) — unless they cannot isolate safely at such place, in which case the person shall lodge at one of the City's designated isolation/quarantine sites — for a period of 14 days and shall comply with all Hawai'i State Department of Health protocols related to positive COVID-19 infection.

Except as expressly modified by this Order/Amendment, the Emergency Order No. 2020-30 (Honolulu’s COVID-19 Recovery Framework: Amended and Restated Order Implementing Tier 2) remains in full force and effect.

This Order/Amendment shall be posted on the City website as soon as practicable in one or more appropriate places. This Order/Amendment shall be effective upon signing and remain posted while in effect.
