
HOUSE CONCURRENT RESOLUTION

ENCOURAGING PARTICIPATION IN THE STATEWIDE BLACK RIBBON AND
BLACK ARM BAND CAMPAIGN AGAINST DOMESTIC VIOLENCE.

1 WHEREAS, according to the Surgeon General, United States
2 Public Health Service, domestic violence is a problem of
3 epidemic proportions; and
4

5 WHEREAS, according to the Community Overcoming Relationship
6 Abuse organization, also known as CORA, a woman is abused every
7 nine seconds, 3,000,000 to 10,000,000 children witness domestic
8 violence every year, and one in five high school females
9 experience dating violence; and
10

11 WHEREAS, a fact sheet prepared by the National Coalition
12 Against Domestic Violence stated that in 1999, there were 8,013
13 reported cases of domestic violence in Hawaii; and

15 WHEREAS, the Honolulu Police Department estimates that it
16 spends up to one-third to one-half of their work time responding
17 to "domestic" calls; and
18

19 WHEREAS, in addition to the physical and psychological
20 effects of domestic violence on the victim and the victim's
21 family, there are job-related consequences; and
22

23 WHEREAS, domestic violence is the number one cause of
24 injury to women, and CORA estimates that it costs the American
25 economy \$8,000,000,000 to \$10,000,000,000 in absenteeism,
26 medical costs, employee turnover, lost productivity, and other
27 costs; and

29 WHEREAS, the goals of the Black Ribbon and Black Arm Band
30 Campaign are to:



- 1 (1) Urge men, women, youth, and seniors to show their
- 2 support for ending all forms of domestic violence;

- 4 (2) Raise awareness of domestic violence in the community;

- 6 (3) Conduct domestic violence education workshops in
- 7 schools, workplaces, and communities;

- 9 (4) Support organizations that deal with the consequences
- 10 of violence;

- 12 (5) Empower victims of domestic violence; and

- 14 (6) Provide a safe haven for victims of domestic violence;

18 WHEREAS, wearing a black ribbon and black arm band is a
19 statement that an individual will never commit, condone, nor
20 remain silent about violence against women; and

22 WHEREAS, wearing a black ribbon or black arm band is a
23 pledge to represent a community free from domestic violence; and

25 WHEREAS, wearing a black ribbon and black arm band
26 encourages reflection and discussion that will lead to personal
27 and collective action among men, women, youth, and seniors to
28 stop all forms of domestic violence; now, therefore,

30 BE IT RESOLVED by the House of Representatives of the
31 Twenty-fourth Legislature of the State of Hawaii, Regular
32 Session of 2008, the Senate concurring, that the Legislature
33 encourages participation in the statewide Black Ribbon and Black
34 Arm Band Campaign against domestic violence; and

36 BE IT FURTHER RESOLVED that certified copies of this
37 Concurrent Resolution be transmitted to the Governor, Director
38 of Human Services, Director of Health, and Executive Director of
39 the Hawaii State Coalition Against Domestic Violence.
