A BILL FOR AN ACT

RELATING TO THE STADIUM AUTHORITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 109-1, Hawaii Revised Statutes, is
2 amended by amending subsection (a) to read as follows:
3 "(a) There shall be within the department of accounting
4 and general services for administrative purposes only, a stadium
5 authority whose responsibility shall be to maintain, operate,
6 and manage the stadium and facilities attached thereto and to
7 provide for the maintenance, operation, management, and
8 promotion of the Kapolei recreational sports complex. The
9 authority shall consist of [~~nine~~] eleven members, of whom nine
10 shall be voting members who shall be appointed by the governor
11 in the manner prescribed by section 26-34[-]; as follows:
12 (1) Three to be appointed directly by the governor;
13 (2) Three to be appointed from a list of nominees from the
14 general public submitted by the president of the
15 senate; and



1 (3) Three to be appointed from a list of nominees from the
2 general public submitted by the speaker of the house
3 of representatives.

4 Each member of the authority shall have been a citizen of the
5 United States and a resident of the State for at least five
6 years next preceding the member's appointment. The president of
7 the University of Hawaii and the superintendent of education
8 shall be ex officio members of the authority but shall not
9 vote."

10 SECTION 2. Upon the enactment of this Act, all
11 appointments with voting authority to the stadium authority
12 shall be made in accordance with section 1 of this Act; provided
13 that:

14 (1) The first, third, and fifth vacancies occurring after
15 the effective date of this Act in the stadium
16 authority membership, other than ex officio membership
17 vacancies, shall be appointed by the governor from
18 lists provided by the president of the senate;

19 (2) The second, fourth, and sixth vacancies occurring
20 after the effective date of this Act in the stadium
21 authority membership, other than ex officio membership
22 vacancies, shall be appointed by the governor from



1 lists provided by the speaker of the house of
 2 representatives; and
 3 (3) The seventh, eighth, and ninth vacancies shall be
 4 appointed directly by the governor.

5 SECTION 3. Statutory material to be repealed is bracketed
 6 and stricken. New statutory material is underscored.

7 SECTION 4. This Act shall take effect upon its approval.
