
A BILL FOR AN ACT

RELATING TO BRIDGE TO HOPE PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the recent changes
2 to the rules of the federal temporary assistance for needy
3 families program, which prohibit baccalaureate education as
4 countable work activities and limit educational activities to
5 one year of vocational education are not consistent with the
6 State's intention to include education and training as one of
7 the pathways to economic self-sufficiency. Although the
8 department of human services has implemented an expanded
9 education policy for first to work participants, Act 276,
10 Session Laws of Hawaii 2000, which amended chapter 346, Hawaii
11 Revised Statutes, to create the bridge to hope education
12 program, applies only to temporary assistance for needy
13 families. Currently, temporary assistance to other needy
14 families participants use the expanded education options due to
15 the recent federal limitations on educational activities.

16 Since its enactment of the bridge to hope post-secondary
17 education benefits program within the department of human



1 services in July of 2000, the legislature has affirmed the
2 State's support for access to post-secondary education by
3 participants in the federally funded temporary assistance for
4 needy families welfare program. Heads of households often
5 require additional skills and knowledge to increase their
6 earning capacity to enable them to earn a self-sufficient wage.
7 Since July 2001, the bridge to hope student employment and
8 academic support program at the University of Hawaii has served
9 over six hundred individuals with one hundred fifty of those
10 individuals earning their associate of arts degrees and seventy
11 others earning their bachelor of arts degrees.

12 The purpose of this Act is to clarify eligibility
13 requirements of and expand the bridge to hope program to enable
14 all heads of households who are receiving financial assistance
15 and participating in the first to work program to pursue a full
16 range of educational activities as part of their work
17 activities.

18 SECTION 2. Section 346-68, Hawaii Revised Statutes, is
19 amended by amending subsections (a) and (b) to read as follows:

20 "(a) There is created within the department a post-
21 secondary education benefits program, to be known as the bridge

3 (b) To receive assistance under this program, the [~~single~~
4 ~~parent~~] participant shall:

5 (1) Be enrolled as a student each term[+] in an approved
6 course of study including, but not limited to,
7 vocational education;

8 (2) Maintain passing grades or better throughout the
9 course of study; and

10 (3) Meet work activity requirements as defined by the
11 department."

12 SECTION 3. Statutory material to be repealed is bracketed
13 and stricken. New statutory material is underscored.

14 SECTION 4. This Act shall take effect upon its approval.
