# HOUSE CONCURRENT RESOLUTION

REQUESTING A MANAGEMENT AND FINANCIAL AUDIT OF THE UNIVERSITY OF  
HAWAII AT MANOA'S ATHLETIC DEPARTMENT.

1           WHEREAS, the stated mission of the University of Hawaii  
2 (UH) at Manoa's Athletic Department (Department) is to operate  
3 dynamic sports programs encouraging student-athletes in their  
4 pursuit of excellence in the realms of academic achievement and  
5 athletic competition at the highest levels; and

7           WHEREAS, true to its mission, the Department has produced  
8 skilled talent and provided quality sports entertainment for  
9 fans and the rest of the community; and  
10

11           WHEREAS, however, especially in recent years, poor athletic  
12 facilities also seem to have taken the spotlight all too often;  
13 and  
14

15           WHEREAS, in early 2007, complaints about a lack of soap in  
16 the athletic facility's showers were aired to call attention to  
17 the wider-reaching inadequacies of the Department; and  
18

19           WHEREAS, the unanswered requests from the UH football  
20 program to improve facilities as well as other aspects of the  
21 Department also came to light during this time; and

23           WHEREAS, such concerns became prime headlines throughout  
24 the state and were broadcast further as ESPN sportscasters  
25 commented on the poor condition of the UH's athletic facilities  
26 during the football team's nationally-televised victory over  
27 Boise State in November 2007; and

29           WHEREAS, a management and financial audit would serve to  
30 improve the Department and restore the public's confidence in  
31 its ability to carry out its mission; now, therefore,



1 BE IT RESOLVED by the House of Representatives of the  
2 Twenty-fourth Legislature of the State of Hawaii, Regular  
3 Session of 2008, the Senate concurring, that the Office of the  
4 Auditor is requested to perform a management and financial audit  
5 of the University of Hawaii at Manoa's Athletic Department for  
6 the fiscal years beginning in 2003 and ending in 2007; and  
7

8 BE IT FURTHER RESOLVED that the Office of the Auditor  
9 report its findings and recommendations to the legislature no  
10 later than twenty days prior to the convening of the Regular  
11 Session of 2009; and  
12

13 BE IT FURTHER RESOLVED that certified copies of this  
14 Concurrent Resolution be transmitted to the Chairperson of the  
15 Board of Regents, President of the University of Hawaii,  
16 Chancellor of the University of Hawaii at Manoa, Interim  
17 Director of Intercollegiate Athletics at the University of  
18 Hawaii at Manoa, and Auditor.
