
A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE HAWAII HEALTH SYSTEMS CORPORATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. This Act is recommended by the governor for
2 immediate passage in accordance with section 9 of article VII of
3 the Constitution of the State of Hawaii.

4 SECTION 2. This emergency appropriation is necessary to
5 ensure that the Hawaii health systems corporation can pay for
6 operation and provision of current levels of service at Leahi
7 hospital, Maluhia, Samuel Mahelona memorial hospital, Lana'i
8 community hospital, Hilo medical center, Ka'u hospital, Kona
9 community hospital, Kohala hospital, and Maui memorial medical
10 center.

11 The purpose of this Act is to appropriate \$25,000,000 in
12 general funds for fiscal year 2007-2008 to adjust accounts
13 payable remittances to no more than forty-five days from the
14 date of the invoice for Hawaii health systems corporation's
15 facilities in order to bring current accounts payable balances
16 that are due to essential vendors. This will allow delivery of
17 goods and services to these facilities to continue on a timely



1 basis so that the facilities will be able to maintain
2 operations.

3 SECTION 3. There is appropriated out of the general
4 revenues of the State of Hawaii the sum of \$25,000,000 or so
5 much thereof as may be necessary for fiscal year 2007-2008 to be
6 expended as follows:

- 7 (1) \$14,000,000 to be used by the Hawaii health systems
8 corporation to pay accounts payable within forty-five
9 days from the date of the invoice for Hawaii health
10 systems corporation's facilities, excluding the Maui
11 memorial medical center located in the Maui region of
12 the Hawaii health systems corporation; and
- 13 (2) \$11,000,000 for Maui memorial medical center;
14 provided that the appropriation of \$11,000,000 to Maui memorial
15 medical center in paragraph (2) shall only be expended if the
16 operating loan that is being negotiated by Maui memorial medical
17 center does not close prior to the effective date of this Act.

18 The sum appropriated shall be expended by the Hawaii health
19 systems corporation for the purposes of this Act.

20 SECTION 4. This Act shall take effect upon its approval.
