
SENATE CONCURRENT RESOLUTION

REQUESTING THE STATE DEPARTMENT OF DEFENSE TO EXTEND THE TIME
FOR ELIGIBILITY TO RECEIVE EDUCATIONAL BENEFITS FOR GUARD
SERVICEMEMBERS WHO HAVE SERVED ON ACTIVE DUTY.

1 WHEREAS, military service offers a tremendous array of
2 educational benefits that can be used while a servicemember is a
3 reservist, a member of the guard, on active duty, or after
4 leaving the service; and
5

6 WHEREAS, such educational benefits are a valuable tool in
7 recruiting individuals to join the military, thus, each
8 servicemember should be provided the opportunity to fully
9 utilize those benefits that each has earned; and
10

11 WHEREAS, the Montgomery GI Bill - Selected Reserve
12 (MGIB - SR) is an education assistance program that was enacted
13 by Congress to benefit the high-quality men and women enrolled
14 in the Selected Reserve of the Army, Navy, Air Force, Marine
15 Corps, and Coast Guard, and the Army and Air National Guard; and

17 WHEREAS, if eligible, a member of the Selected Reserve or
18 National Guard can use the MGIB-SR towards any degree programs,
19 certificate or correspondence courses, cooperative training,
20 independent study programs, apprenticeship/on-the-job training,
21 and vocational flight training programs; and

23 WHEREAS, in Hawaii, state educational benefits are also
24 available to members of the Hawaii National Guard through the
25 Hawaii National Guard State Tuition Assistance Program, which
26 provides one hundred per cent coverage for community colleges
27 and fifty per cent coverage for four-year colleges; and

29 WHEREAS, however, such servicemember in the Hawaii National
30 Guard who is called to active duty is unable to take advantage
31 of state educational benefits during the time of active duty;

2 WHEREAS, upon return from active duty, the servicemember is
3 further unable to utilize the state educational benefits once
4 the servicemember's enlistment has ended, thereby not being
5 afforded the full benefit promised upon entry into military
6 service; and

8 WHEREAS, these committed servicemembers of the Hawaii
9 National Guard who are called to active duty should not be
10 penalized for their service to their country; now, therefore,

11
12 BE IT RESOLVED by the Senate of the Twenty-fourth
13 Legislature of the State of Hawaii, Regular Session of 2008, the
14 House of Representatives concurring, that the State Department
15 of Defense is requested to provide state educational benefits to
16 members of the Hawaii National Guard who are called to active
17 duty; and

19 BE IT FURTHER RESOLVED that the State Department of Defense
20 is requested to consider tolling the time for eligibility for
21 educational benefits by guard servicemembers during the time
22 that they are called to active duty or providing a fixed
23 extended period of time to such servicemembers, as appropriate;

26 BE IT FURTHER RESOLVED that a certified copy of this
27 Concurrent Resolution be transmitted to the Adjutant General.
