
SENATE RESOLUTION

ESTABLISHING A TASK FORCE TO REVIEW THE RETIREMENT AGE FOR STATE COURT JUSTICES AND JUDGES; THE TERMS OF AND POSSIBLE TERM LIMITS FOR STATE COURT JUSTICES AND JUDGES; THE POSSIBILITY OF ESTABLISHING A SENIOR JUDGE SYSTEM FOR STATE COURT JUSTICES AND JUDGES; JUDICIAL ACCOUNTABILITY AND FITNESS IN THE STATE OF HAWAII; AND RELATED MATTERS.

1 WHEREAS, Article VI, Section 3, of the Constitution of the
2 State of Hawaii currently requires that state court justices and
3 judges retire from the bench upon attaining the age of seventy
4 years; and

5
6 WHEREAS, Senate Bill No. 995, Regular Session of 2006,
7 proposed a repeal of the constitutional provision mandating the
8 retirement of justices and judges at age seventy; and

9
10 WHEREAS, Senate Bill No. 995 passed both the House of
11 Representatives and the Senate by the two-thirds vote, as
12 required by Article XVII, Section 3, of the Constitution of the
13 State of Hawaii; and

14
15 WHEREAS, the proposed repeal of the mandatory retirement
16 age for justices and judges was duly placed on the ballot and
17 submitted to the voters for ratification or rejection at the
18 general election on November 7, 2006; and

19
20 WHEREAS, only 34.8 per cent of the electorate voted in
21 favor of the repeal and 57.8 per cent of the electorate voted
22 against repealing the mandatory retirement age for justices and
23 judges; and

24
25 WHEREAS, the proposed repeal of the mandatory retirement
26 age for justices and judges failed to obtain the majority of all
27 the votes tallied upon the proposal and was therefore rejected;
28 and

29
30 WHEREAS, Hawaii has no term limits for judges and justices;
31 Hawaii has no senior judge system; and the system of judicial



1 accountability and determining judicial fitness has not been
2 studied; and

4 WHEREAS, major concerns with the proposed amendment
5 included the lack of any careful study of:

6

7 (1) The effects of a repeal of the retirement age on the
8 Judiciary and the administration of justice, including
9 a study of whether the retirement age should be
10 retained, altered, or eliminated and, if so, whether
11 prospectively only;

12

13 (2) Whether there should be term limits for state court
14 justices and judges;

15

16 (3) Whether there should be a senior judge system for
17 state court justices and judges; and

18

19 (4) Whether there is currently sufficient judicial
20 accountability and means for determining judicial
21 fitness; and

22

23 WHEREAS, a study:

24

25 (1) Reviewing the practices of other jurisdictions
26 regarding: the regulation of judicial retirement,
27 term limits for judges, a senior judge system,
28 judicial accountability, and means for determining
29 judicial fitness;

30

31 (2) Identifying public policies promoted or impeded by:
32 the current Hawaii mandatory judicial retirement age
33 or its alternatives, the lack of judicial terms limits
34 in Hawaii, the lack of a senior judge system in
35 Hawaii, the current Hawaii system of judicial
36 accountability, and the current Hawaii means for
37 determining judicial fitness; and

39 (3) Collecting data on the impact of changing any of the
40 above;

41

42 would be valuable in facilitating an informed discussion of,
43 evaluating the merits of retaining, repealing, or amending, the
44 current Hawaii: mandatory judicial retirement age, including if



1 there is to be a change whether it should be prospective only;
2 lack of judicial terms limits; lack of a senior judge system;
3 system of judicial accountability; means for determining
4 judicial fitness; now, therefore,

5
6 BE IT RESOLVED by the Senate of the Twenty-fourth
7 Legislature of the State of Hawaii, Regular Session of 2008,
8 that a task force be convened to:

- 9
10 (1) Collect relevant data, including, but not limited to,
11 practices in other jurisdictions;
12
13 (2) Identify public policies promoted or impeded by, and
14 make recommendations on the repeal, amendment, or
15 retention of the:
16
17 (A) Mandatory judicial retirement age;
18
19 (B) Lack of judicial terms limits;
20
21 (C) Lack of a senior judge system;
22
23 (D) Current system of judicial accountability; and
24
25 (E) Current means for determining judicial fitness;
26 and

27
28 BE IT FURTHER RESOLVED that the task force be composed of
29 the following members:

- 30
31 (1) The Dean of the William S. Richardson School of Law,
32 who is requested to serve as the chairperson;
33
34 (2) The Attorney General, or the Attorney General's
35 designee;
36
37 (3) The United States Attorney for the District of Hawaii,
38 or designee;
39
40 (4) A representative from each county prosecuting
41 attorney's office;

43 (5) A representative from the Office of the Public
44 Defender;



- 2 (6) A representative from the Hawaii State Bar
- 3 Association;
- 4
- 5 (7) The Chairperson of the Judicial Selection Commission,
- 6 or the Chairperson's designee;
- 7
- 8 (8) A representative of the appellate judges of Hawaii, to
- 9 be selected by the Chief Justice;
- 10
- 11 (9) A representative of the district and circuit judges of
- 12 Hawaii, to be selected by them; and
- 13
- 14 (10) A member of the public, to be appointed by the
- 15 Governor; and
- 16

17 BE IT FURTHER RESOLVED that the University of Hawaii is
18 requested to provide administrative, clerical, and other
19 necessary staff support to the task force; and
20

21 BE IT FURTHER RESOLVED that the task force is requested to
22 report its findings and recommendations, including any proposed
23 legislation, to the Legislature no later than twenty days prior
24 to the convening of the Regular Session of 2009; and
25

26 BE IT FURTHER RESOLVED that certified copies of this
27 Resolution be transmitted to the Dean of the William S.
28 Richardson School of Law, the Attorney General, the United
29 States Attorney for the District of Hawaii, the Prosecuting
30 Attorney for each county, the Office of the Public Defender, the
31 President of the Hawaii State Bar, the Chairperson of the
32 Judicial Selection Commission, the Chief Justice, the
33 Administrative Director of the Courts, the Governor, and the
34 President of the University of Hawaii.
