
A BILL FOR AN ACT

RELATING TO REDUCED IGNITION PROPENSITY CIGARETTES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 132C-4, Hawaii Revised Statutes, is
2 amended by amending its title and subsection (a) to read as
3 follows:

4 "~~§~~132C-4~~§~~ **Certification; marking~~[-]~~; administration.**

5 (a) Each manufacturer shall submit to the state fire council
6 written certification attesting that each cigarette has been
7 tested in accordance with, and has met the performance standard
8 required under, section 132C-3. The description of each
9 cigarette listed in the certification shall include:

- 10 (1) The brand or trade name on the package;
- 11 (2) Style, such as light or ultra light;
- 12 (3) Length in millimeters;
- 13 (4) Circumference in millimeters;
- 14 (5) Flavor, such as menthol, if applicable;
- 15 (6) Filter or nonfilter;
- 16 (7) Package description, such as a soft pack or box;
- 17 (8) The mark approved pursuant to subsection (b);

1 (9) The name, address, and telephone number of the
2 laboratory, if different than the manufacturer that
3 conducted the test; and

4 (10) The date that the testing occurred.

5 Each cigarette certified under this subsection shall be
6 recertified every three years. For each cigarette listed in a
7 certification, a manufacturer shall pay to the state fire
8 council a \$375 fee. The state fire council shall hire personnel
9 to administer the reduced ignition propensity cigarette program
10 and to cover any costs associated with the program, including
11 processing, testing, enforcement, inspections, and oversight.

12 The state fire council is authorized to annually adjust this fee
13 to ensure it defrays the actual costs of the administration,
14 processing, testing, enforcement, inspection, and oversight
15 activities required by this chapter.

16 The certifications shall be made available to the attorney
17 general for purposes consistent with this chapter."

18 SECTION 2. Section 132C-8, Hawaii Revised Statutes, is
19 amended to read as follows:

20 "[+]§132C-8[+] **Existing inventories; consumer testing.**

21 The requirement that cigarettes sold in Hawaii must be in
22 compliance with this chapter shall not prohibit:

1 (1) Wholesalers or dealers from selling existing cigarette
2 inventories on or after September 30, [~~2009~~] 2010;
3 provided that the wholesaler or dealer can establish
4 both of the following to the satisfaction of the state
5 fire council:

6 (A) The Hawaii tax stamps were affixed to the
7 cigarettes pursuant to chapter 245 prior to
8 September 30, [~~2009~~] 2010; and

9 (B) The inventory was purchased prior to September
10 30, [~~2009~~] 2010, and the purchased inventory is
11 comparable to the amount of inventory purchased
12 during the same period the previous year; or

13 (2) The sale of cigarettes solely for the purpose of
14 consumer testing. For the purposes of this paragraph,
15 the term "consumer testing" means an assessment of
16 cigarettes that is conducted by or under the control
17 and direction of a manufacturer for the purpose of
18 evaluating consumer acceptance of cigarettes, using
19 only the quantity of cigarettes that is reasonably
20 necessary for the assessment, and in a controlled
21 setting where the cigarettes are either consumed on-

1 site or returned to the testing administrators at the
2 conclusion of the testing."

3 SECTION 3. Act 218, Session Laws of Hawaii 2008, is
4 amended by amending section 6 to read as follows:

5 "SECTION 6. This Act shall take effect on September 30,
6 [~~2009~~] 2010, and shall be implemented to coincide with the
7 excise tax incremental increase on cigarettes effective
8 September 30, [~~2009~~] 2010, pursuant to section 245-3, Hawaii
9 Revised Statutes; provided that section 4 shall take effect upon
10 approval of this Act; provided further that section [~~5(1)~~]
11 132C-5(1), Hawaii Revised Statutes, shall take effect upon
12 approval of this Act."

13 SECTION 4. Statutory material to be repealed is bracketed
14 and stricken. New statutory material is underscored.

15 SECTION 5. This Act shall take effect on July 1, 2050.
