Subject: S.B. 1061 Relating to Fire Protection

I am Kenneth G. Silva, Chair of the State Fire Council (SFC) and Fire Chief of the Honolulu Fire Department (HFD). The SFC and the HFD support S.B. 1061, which proposes to prohibit retail sales or the distribution of novelty lighters.

Novelty lighters contain features that are attractive to children, including visual effects, flashing lights, musical sounds, or toy-like designs. Since 1996, the Consumer Product Safety Commission has recalled thousands of novelty lighters due to their danger to public safety. Juvenile fire setting has been identified as the fastest growing fire threat in the U.S. More than 300 people have been killed, of which 30 percent were children, and almost \$1 billion in property was destroyed.

During 2003-2007 in the City and County of Honolulu, fires caused by children playing with lighters resulted in an estimated \$1,284,100 in property and content damages, three fire fatalities, and six injuries.

Many local and national public safety agencies support prohibiting the sale and distribution of novelty lighters, including the National Fire Protection Association, the Western Fire Chiefs Association, and the National Association of State Fire Marshals. The function of a lighter can be achieved without the novelty attraction to children. There is no logical reason for lighters to be made to attract greater curiosity and invite dangerous behavior, which can result in tragedy and destruction.

The SFC and the HFD urge your committee's support on the passage of S.B. 1061, which will reduce the incidence of children playing with lighters.
