
A BILL FOR AN ACT

RELATING TO ENERGY INDUSTRY REPORTING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 486H-13, Hawaii Revised Statutes, is
2 amended as follows:

3 1. By amending subsection (l) to read:

4 "(l) The suspension of the maximum pre-tax wholesale
5 gasoline price shall suspend the commission's duty to calculate
6 and publish the maximum pre-tax wholesale gasoline price that
7 would have been in effect but for the suspension, but shall not
8 suspend or affect:

9 (1) Any duty to register, timely provide information, make
10 a report, or file a statement under chapter 486J; or

11 (2) Any duty of the commission to[+]

12 ~~(A) Timely obtain, analyze, or publicly disclose or~~
13 ~~report information under chapter 486J; and~~

14 ~~(B) Enforce]~~ enforce chapter 486B."

15 2. By amending subsection (n) to read:

16 "(n) The [~~commission~~] department of business, economic
17 development, and tourism shall have the power to determine the



1 extent to which a manufacturer, wholesaler, or jobber is
 2 complying with any requirement imposed or rule adopted under
 3 this section, including the power to compel a manufacturer,
 4 wholesaler, or jobber to submit documents, data, and information
 5 necessary and appropriate for the [~~commission~~] department of
 6 business, economic development, and tourism to determine [~~such~~]
 7 compliance. [~~The commission may use data collected pursuant to~~
 8 ~~chapter 486J in determining such compliance.~~]"

9 SECTION 2. Section 486J-1, Hawaii Revised Statutes, is
 10 amended as follows:

11 1. By adding three new definitions to read:

12 "Biofuels" means liquid or gaseous fuels produced from
 13 organic sources such as biomass crops, agricultural residues,
 14 and oil crops, such as palm oil, canola oil, soybean oil, waste
 15 cooking oil, grease, and food wastes, animal residues and
 16 wastes, and sewage and landfill wastes.

17 "Inventory" means the volume, in barrels, of reserve that
 18 is normally maintained by the reporting entity on a monthly
 19 basis.

20 "Storage capacity" means the maximum volume, in barrels, of
 21 used and useful facility capacity for storage."



1 2. By repealing the definitions of "competitively priced",
2 "corporate overhead expenses", "dealer tank wagon price", "major
3 fuel user", "major marketer", "major oil producer", "major oil
4 storer", "major oil transporter", "nonrefiner wholesale price",
5 "refiner wholesale price", and "wholesale liquid fuel prices".

6 ~~["Competitively priced" means fuel grade ethanol for which
7 the wholesale price, minus the value of all applicable federal,
8 state, and county tax credits and exemptions, is not more than
9 the average posted rack price of unleaded gasoline of comparable
10 grade published in the State.~~

11 ~~"Corporate overhead expenses" means the expenses or costs
12 allocated by the refiners that reflect their Hawaii business
13 units' share of corporate staff costs, such as legal, finance,
14 accounting, information technology, and similar costs.~~

15 ~~"Dealer tank wagon price" means the wholesale price at
16 which liquid fuel is sold to any retail outlet by any
17 distributor priced on a delivered basis to a retail outlet.~~

18 ~~"Major fuel user" means any person who uses fuel in the
19 manufacture of products or for the generation of power in
20 amounts determined by the commission as having a major effect on
21 energy supplies.~~



1 ~~"Major marketer" means any person who sells natural gas,~~
2 ~~propane, synthetic natural gas, or oil in amounts determined by~~
3 ~~the commission as having a major effect on energy supplies.~~

4 ~~"Major oil producer" means any person who produces oil in~~
5 ~~amounts determined by the commission as having a major effect on~~
6 ~~energy supplies.~~

7 ~~"Major oil storer" means any person who stores oil or other~~
8 ~~petroleum products in amounts determined by the commission as~~
9 ~~having a major effect on energy supplies.~~

10 ~~"Major oil transporter" means any person who transports oil~~
11 ~~or other petroleum products in amounts determined by the~~
12 ~~commission as having a major effect on energy supplies.~~

13 ~~"Nonrefiner wholesale price" means the wholesale price at~~
14 ~~which liquid fuel is sold by any distributor, not a refiner, to~~
15 ~~any other distributor, not a refiner, for resale at any~~
16 ~~subsequent wholesale or retail transaction.~~

17 ~~"Refiner wholesale price" means the wholesale price at~~
18 ~~which liquid fuel is sold by a refiner to any distributor, not a~~
19 ~~refiner, for resale at any subsequent wholesale or retail~~
20 ~~transaction.~~

21 ~~"Wholesale liquid fuel prices" means the prices at which~~
22 ~~liquid fuel is sold at wholesale for resale at wholesale or~~



1 ~~retail, typically but not limited to gasoline and diesel for~~
2 ~~motor vehicles, and include "dealer tank wagon price",~~
3 ~~"nonrefiner wholesale price", and "refiner wholesale price"."]~~

4 SECTION 3. Section 486J-3, Hawaii Revised Statutes, is
5 amended to read as follows:

6 "§486J-3 Statements. [(a)] Each [week] month, every
7 refiner and distributor [~~and major fuel user shall file with the~~
8 ~~commission, on forms prescribed, prepared, and furnished by the~~
9 ~~commission, a certified statement showing on a statewide~~
10 ~~consolidated basis, and], on a reporting date established by the
11 director, shall file on forms furnished by the department
12 showing separately for each county and for the islands of Lanai
13 and Molokai within which and whereon fuel is sold or used during
14 the last preceding reporting [~~week,~~] month, the following:~~

- 21 (1) The total volume of fuel imported into and exported
22 from Hawaii, and if for ultimate sale or consumption

2 volume of fuel, in barrels, by import location
3 (foreign and domestic), by specific crude oil
4 imported, and by liquid fuel type, aviation fuel,
5 diesel fuel, biofuels, and other types of fuel as
6 required by the department, that is sold, exchanged,
7 or otherwise transferred or used by the distributor;

8 (2) The total volume of fuel refined, manufactured, or
9 compounded by refineries, in barrels, by company, and
10 by specific crude oil and by liquid fuel type,
11 aviation fuel, diesel fuel, biofuels, and other types
12 of fuel as required by the department, including No. 2
13 diesel fuel, No. 1 distillate, No. 2 fuel oil, No. 4
14 fuel oil, kerosene, finished aviation gasoline,
15 kerosene-type jet fuel, residual fuel oil, consumer
16 grade propane, and gasoline (regular, midgrade, and
17 premium);

18 (3) The total volume of fuel distributed, in barrels, by
19 company, by island, and by liquid fuel type, aviation
20 fuel, diesel fuel, biofuels, and other types of fuel
21 as required by the department, and by:

22 (A) Classes of retail trade;



1 (B) Federal, state, county agencies, ships stores, or
2 base exchanges, commercial agriculture accounts,
3 commercial non-agriculture accounts, retail
4 dealers, and other customers as required by the
5 department; and

6 (C) Wholesale distributor; and

7 (4) The total volume of inventory and storage capacity, in
8 barrels, by reporting entity, by method of
9 transportation of receipts and distribution, by
10 specific crude oil, and by liquid fuel type, aviation
11 fuel, diesel fuel, biofuels, and other types of fuel
12 as required by the department.

13 ~~[(b) Each major marketer shall submit to the commission,~~
14 ~~at a time and in a form as the commission shall prescribe,~~
15 ~~information, including petroleum and petroleum product receipts,~~
16 ~~exchanges, inventories, and distributions.~~

17 ~~(c) The commission may require additional information as~~
18 ~~and when the commission deems necessary to perform the~~
19 ~~commission's responsibilities under this chapter.~~

20 ~~(d) Information in the statements filed pursuant to this~~
21 ~~section shall be collected and maintained for the purpose of~~

4 SECTION 4. Section 486J-5.5, Hawaii Revised Statutes, is
5 amended to read as follows:

6 " ~~[+] §486J-5.5 [+] [Petroleum industry monitoring, analysis,~~
7 ~~and reporting] Energy data collection program. The [commission]~~
8 ~~department shall establish the [petroleum industry monitoring,~~
9 ~~analysis, and reporting] energy data collection program that~~
10 ~~includes development and maintenance of an [automated petroleum~~
11 ~~industry information reporting] energy database system that~~
12 ~~meets the requirements of government [7] and industry, [and the~~
13 ~~public] while promoting sound policy making [and consumer~~
14 ~~information and protection. The purpose of the petroleum~~
15 ~~industry monitoring, analysis, and reporting program is to~~
16 ~~conduct and facilitate the efficient analysis and reporting of~~
17 ~~all information and data provided by the petroleum industry~~

4 SECTION 5. Section 486J-6, Hawaii Revised Statutes, is
5 amended to read as follows:

6 "§486J-6 Confidential information. (a) Confidential
7 commercial information provided to the [~~commission~~] department
8 pursuant to this chapter that is exempt from public disclosure
9 under section 92F-13 shall be held in confidence by the
10 [~~commission~~] department or aggregated to the extent necessary in
11 the [~~commission's~~] department's discretion to ensure
12 confidentiality as required by chapter 92F.

13 (b) No data or information submitted to the [~~commission~~]
14 department shall be deemed confidential if it is shown that the
15 person submitting the information or data has made it public.

16 (c) Unless otherwise provided by law, with respect to data
17 that the commission [~~obtains~~] or department obtained or [~~is~~] was
18 provided pursuant to section 486J-3, 486J-4, 486J-4.5, or
19 486J-5[7] prior to their repeal, neither the commission or
20 department nor any employee of the commission or department may
21 do any of the following:

12 SECTION 6. Section 486J-7, Hawaii Revised Statutes, is

15 **state agency.** Any confidential information pertinent to the

16 responsibilities of the commission or the department specified

17 in this chapter that is obtained by another state agency,

18 including the department of taxation, the attorney general, and

19 the consumer advocate, shall be available only to the attorney

20 general, the attorney general's authorized representatives, the

21 department of business, economic development, and tourism, and

22 the commission and shall be treated in a confidential manner."



1 SECTION 7. Section 486J-9, Hawaii Revised Statutes, is
2 amended by amending subsections (a), (b), and (c) to read as
3 follows:

5 persons who have failed to timely provide the information
6 specified in section 486J-3 [~~, 486J-4, or 486J-4.5~~] or requested
7 by the [~~commission~~] department under section 486J-3 [~~, 486J-4, or~~
8 ~~486J-4.5~~]. If, within five business days after being notified
9 of the failure to provide the specified or requested
10 information, the person fails to supply the specified or
11 requested information, the person shall be subject to a civil
12 penalty of not less than \$50,000 per day nor more than \$100,000
13 per day for each day the submission of information is refused or
14 delayed.

15 (b) Any person, or any employee of any person, who
16 wilfully makes any false statement, representation, or
17 certification in any record, report, plan, or other document
18 filed with the [~~commission~~] department shall be subject to a
19 civil penalty not to exceed \$500,000 and shall be deemed to have
20 committed an unfair or deceptive act or practice in the conduct
21 of a trade or commerce and subject to the penalties specified in
22 chapters 480 and 486B.

2 under subsection (a) or (b) to the attorney general, who may
3 exercise any appropriate legal or equitable remedies that may be
