A BILL FOR AN ACT

RELATING TO KANEOHE BAY REGIONAL COUNCIL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 200D-2, Hawaii Revised Statutes, is
2 amended by amending subsection (a) to read as follows:
3 "(a) There is established within the department of land
4 and natural resources, for administrative purposes only, the
5 Kaneohe Bay regional council [~~which~~]; provided that except for
6 the participation on the council of the two representatives from
7 the department of land and natural resources as ex-officio
8 nonvoting members pursuant to subsection (c) and except as
9 provided under section 26-35, the department of land and natural
10 resources shall not provide administrative support to the
11 council, including providing staff, drafting, and other support
12 at council meetings. The council shall be composed of seven
13 voting members appointed by the governor in accordance with
14 section 26-34 and ex officio nonvoting members as provided in
15 subsection (c). The members shall serve without compensation."
16 SECTION 2. Section 200D-4, Hawaii Revised Statutes, is
17 amended to read as follows:

6 SECTION 3. Section 200D-5, Hawaii Revised Statutes, is
7 amended to read as follows:

8 " ~~[-] §200D-5 [+]~~ Annual report. The council shall submit
9 ~~[semi-annual reports]~~ an annual report on its activities to the
10 governor and the legislature, which may include recommendations;
11 provided that the recommendations are consistent with the
12 purposes of this chapter."

13 SECTION 4. Act 68, Session Laws of Hawaii 2009, is
14 repealed.

15 SECTION 5. Statutory material to be repealed is bracketed
16 and stricken. New statutory material is underscored.

17 SECTION 6. This Act shall take effect upon its approval.
