A BILL FOR AN ACT

RELATING TO THE BOARDS OF WATER SUPPLY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 54-25, Hawaii Revised Statutes, is
2 amended to read as follows:

3 "**§54-25 Disbursement of fund.** The county treasurer shall
4 disburse all [~~monies~~] moneys of the board [~~of water supply~~] only
5 upon warrants issued by the county auditor or other county
6 authorized signatory on accounts payable vouchers signed by the
7 chairperson or the acting chairperson of the board[-], except as
8 provided herein. The board may delegate, through rules and
9 policies adopted pursuant to chapter 91, its powers and duties
10 regarding the disbursement of funds to the manager and chief
11 engineer."

12 SECTION 2. Statutory material to be repealed is bracketed
13 and stricken. New statutory material is underscored.

14 SECTION 3. This Act shall take effect upon its approval.
