SENATE CONCURRENT RESOLUTION

REQUESTING THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES TO AUTHORIZE THE JOINT LEGISLATIVE COMMITTEE ON AGING IN PLACE TO CONTINUE TO MEET AND CARRY OUT THE WORK OF THE COMMITTEE.

1 WHEREAS, the Joint Legislative Committee on Family
2 Caregiving was established by Act 285, Session Laws of Hawaii
3 2006, for the purpose of developing a comprehensive public
4 policy to strengthen support for family caregivers who provide
5 unpaid, informal assistance to persons age sixty and older with
6 physical or cognitive disabilities; and
7

8 WHEREAS, the committee was directed to consider providing
9 support in categories including but not limited to coordinated
10 services and policies, training and education, respite services,
11 financial incentives, and balancing work and caregiving; and
12

13 WHEREAS, Act 285, Session Laws of Hawaii 2006, also
14 required the committee to submit its findings and
15 recommendations to the legislature no later than twenty days
16 prior to the convening of the regular session of 2007; and
17

18 WHEREAS, in the fall of 2006, the committee held numerous
19 meetings and submitted a special committee report to the
20 legislature, which outlined its proposal for the establishment
21 of a comprehensive and sustainable community-based family
22 caregiver support system that will maximize resources in all
23 communities; and
24

25 WHEREAS, in 2007, the Legislature found that it was still
26 necessary to gather more information on family caregiving, to
27 enable the State to apply resources and services in a more
28 effective manner; and

1 WHEREAS, in 2007, the Legislature also recognized that
2 grandparents who are caregivers for their grandchildren
3 experience similar support needs and caregiving costs as do
4 family caregivers for older adults, and that the National Family
5 Caregiver Support Program under the reauthorized Older Americans
6 Act includes grandparents of grandchildren age eighteen years
7 and younger or nineteen years of age or older with physical and
8 cognitive limitations; and
9

10 WHEREAS, Act 204, Session Laws of Hawaii 2007, expanded the
11 mandate of the joint legislative committee by amending the
12 definition of "family caregiver" to include non-relatives who
13 provide unpaid, informal assistance to persons age sixty and
14 older with physical or cognitive disabilities, and grandparents
15 who are caregivers for grandchildren who are eighteen years of
16 age or younger, or who are nineteen years of age or older with
17 physical or cognitive limitations; and
18

19 WHEREAS, during the 2007 interim, the committee examined
20 localized studies and surveys, some of which contained
21 preliminary results, which provided concrete evidence of the
22 needs of family caregivers, and the committee studied what other
23 states have done and are doing in response to the growing
24 concern regarding eldercare issues; and
25

26 WHEREAS, the Legislature recognized that the committee
27 needed more time to complete its work, and in Act 220, Session
28 Laws of Hawaii 2008, extended the term of the committee to June
29 30, 2010, and changed the name of the committee to the Joint
30 Legislative Committee on Aging in Place; and
31

32 WHEREAS, during the 2009 interim, the committee continued
33 to gather information in areas that advance family caregiver
34 support and improve conditions for enabling elders to age in
35 place; and
36

37 WHEREAS, on January 25, 2010, the Joint Legislative
38 Committee on Aging in Place submitted a report to the
39 Legislature, which contained findings and recommendations in the
40 areas of interest to the committee, including the Kupuna Care
41 and Preservation of the Safety Net, Aging and Disability
42 Resource Center, Grandparents Raising Grandchildren, Home for
43 Life Task Force, Home Care Concierge Service, Fall Prevention,



1 Home Care Agency Licensure, University of Hawaii Center on
2 Aging, and Long Term Care Commission; and

3
4 WHEREAS, the current fiscal constraints on the State have
5 caused the committee to defer a number of its recommendations,
6 including the following: providing additional funding for the
7 Kupuna Care Program, Aging and Disability Resource Center,
8 University of Hawaii Center on Aging, Sage PLUS for the neighbor
9 islands, and cash and counseling model; providing new funding
10 for a respite care directory, caregiver assistance, and home
11 modification tax credits; and providing a funding mechanism to
12 expand the paid family leave program to include family
13 caregivers; and

14
15 WHEREAS, the Joint Legislative Committee on Aging in Place
16 continues to monitor progress on its areas of interest and the
17 legislation it has proposed; and

18
19 WHEREAS, the Joint Legislative Committee on Aging is
20 scheduled to terminate on June 30, 2010; and

21
22 WHEREAS, to accomplish the purpose for which it was
23 established, it is important that the members of the committee
24 continue to meet beyond the date on which it is set to end; now,
25 therefore,

27 BE IT RESOLVED by the Senate of the Twenty-fifth
28 Legislature of the State of Hawaii, Regular Session of 2010, the
29 House of Representatives concurring, that the President of the
30 Senate and Speaker of the House of Representatives are requested
31 to authorize the Joint Legislative Committee on Aging in Place
32 to continue to meet until June 30, 2012; and

34 BE IT FURTHER RESOLVED that the President of the Senate and
35 Speaker of the House of Representatives are urged to request
36 that the members of the Joint Legislative Committee on Aging in
37 Place submit any additional findings and recommendations to the
38 Legislature no later than twenty days prior to the convening of
39 the regular sessions of 2011 and 2012, respectively; and

41 BE IT FURTHER RESOLVED that the Legislature urges the
42 Department of Health, the Department of Human Services, the
43 Department of Taxation, the University of Hawaii, the Executive
44 Office on Aging, and the elderly, disability, business, and



1 faith communities, to continue to assist the members of the
2 joint legislative committee in its efforts to continue the work
3 mandated by Act 285, Session Laws of Hawaii 2006, as amended;
4 and

6 BE IT FURTHER RESOLVED that certified copies of this
7 Concurrent Resolution be transmitted to the President of the
8 Senate, Speaker of the House of Representatives, members of the
9 Joint Legislative Committee on Aging in Place, the Director of
10 Health, Director of Human Services, Director of Taxation, the
11 President of the University of Hawaii, and the Director of the
12 Executive Office on Aging.
